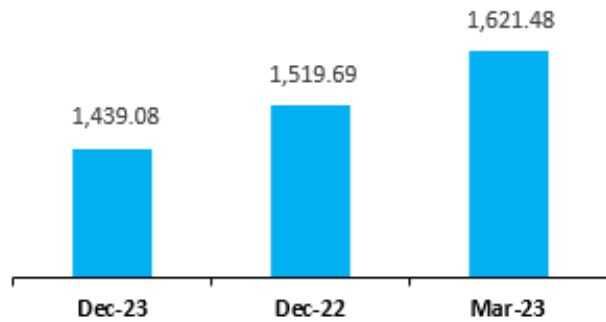

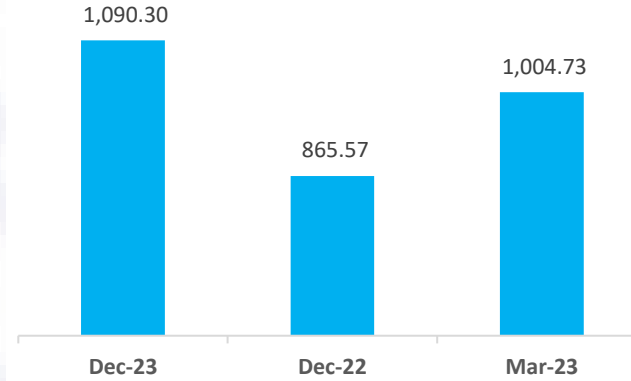

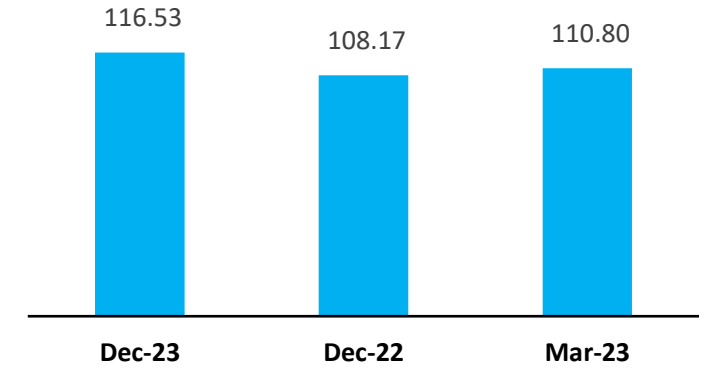
Gross Loan Book (Rs. in cr)



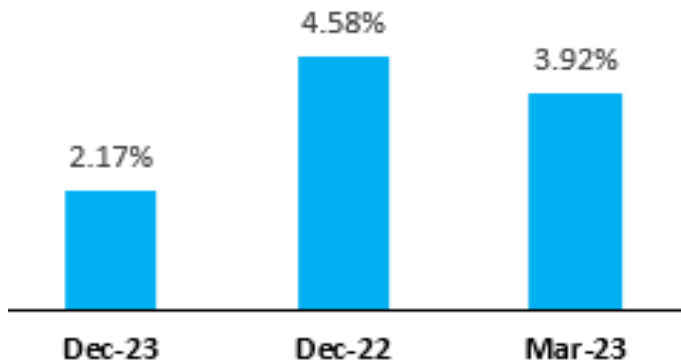
Borrowings (Rs. in cr)



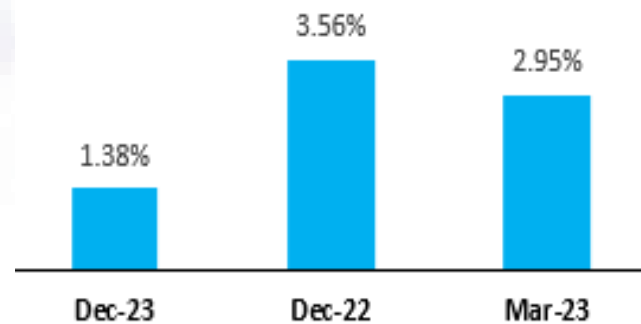
Book Value per Share (Rs.)



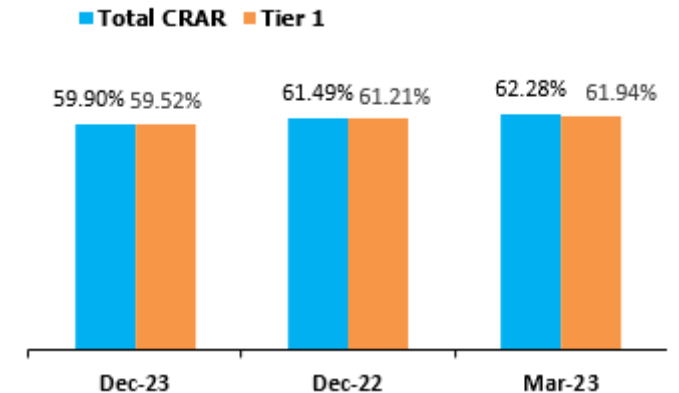
Gross NPL (%)



Net NPL (%)



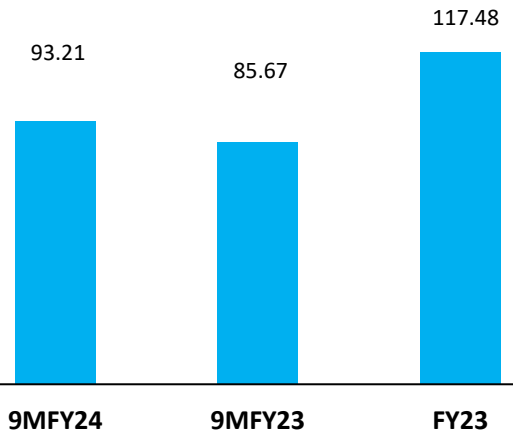
Capital Adequacy Ratio (%)



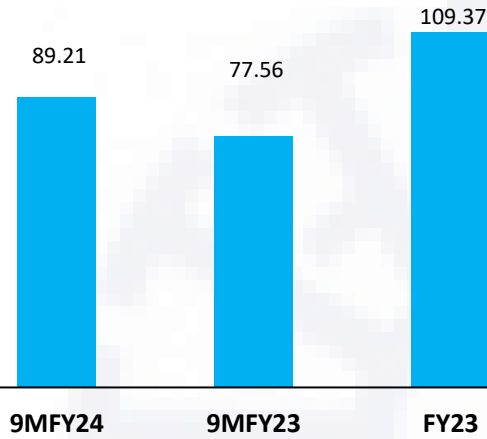

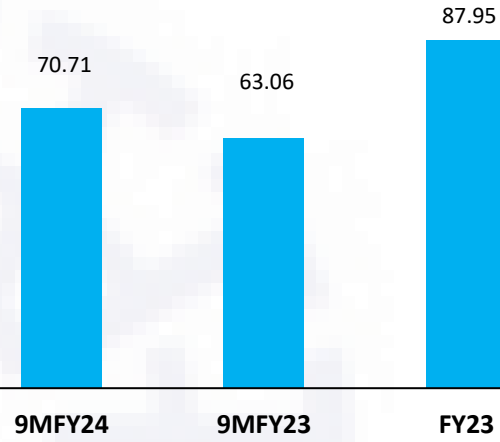
Profit before provision and tax (Rs. in cr)



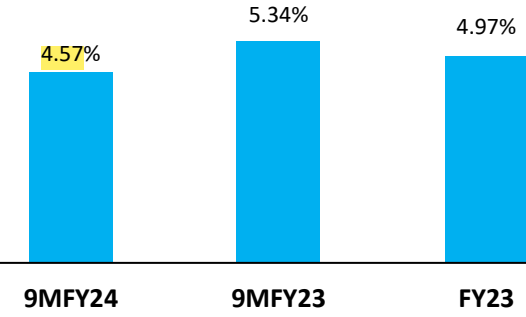

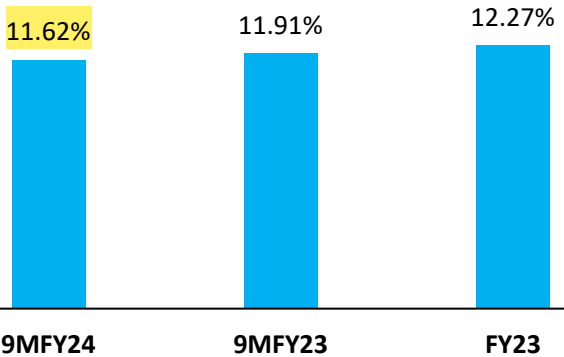

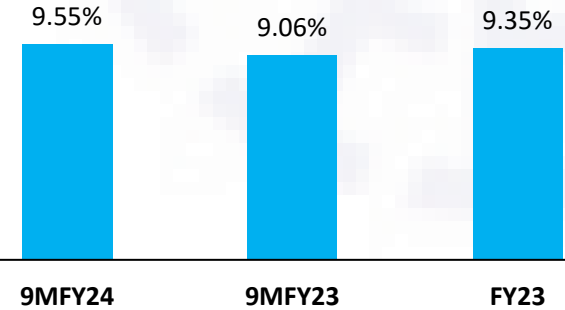

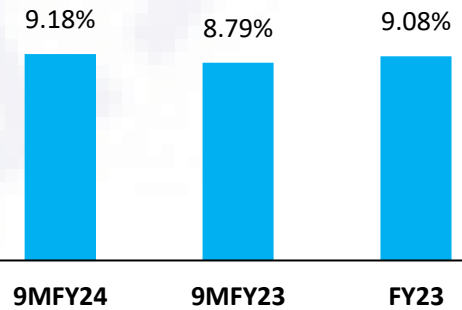
Return on Loans (%)



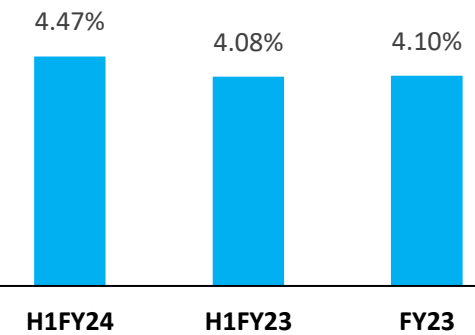
Cost of Borrowings (%)

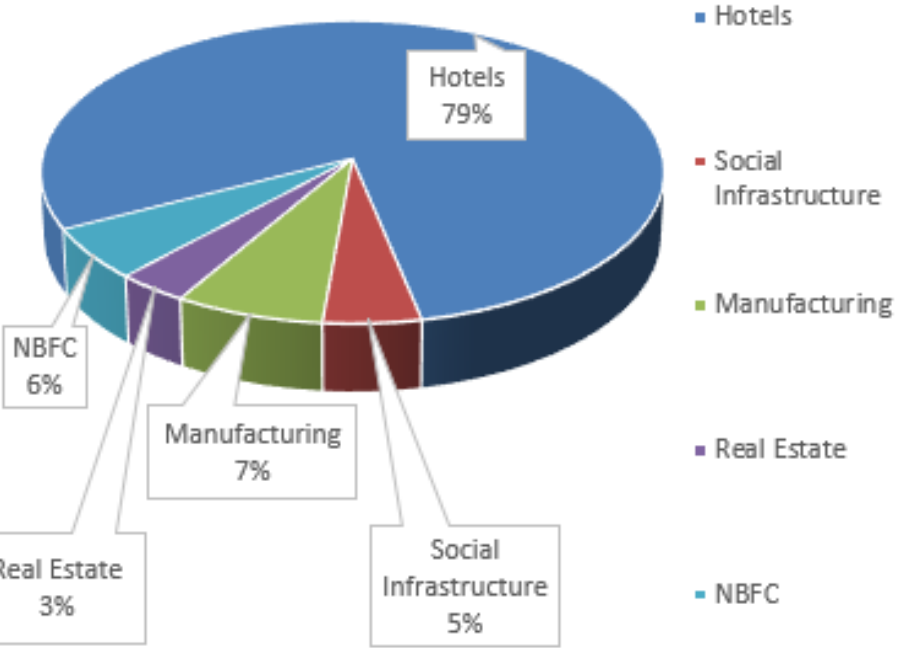

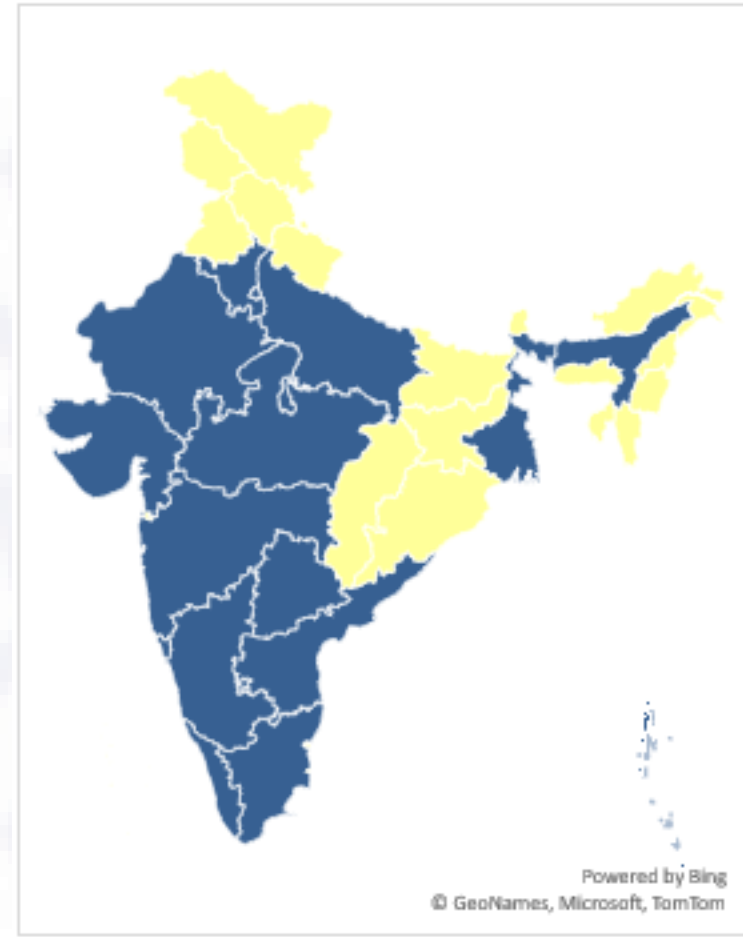
