Udaipur Cement Works Ltd. (UCWL) a subsidiary of JK Lakshmi Cement Ltd (JKLC), a Flagship Company of JK Organization today announced its Financial Results for the Fourth Quarter of Financial Year 2023.

**OPERATIONAL HIGHLIGHTS**

1. Net Sales increased by 18% in FY'23 over FY'22.
2. Sales Volume increased by 4% to 20.35 Lac Tonnes in FY'23 from 19.49 Lac Tonnes in FY'22.
3. The Company's Clinker Capacity Utilization was over 100% during Q4FY23.
4. Company achieved highest ever Clinker Production of 14.44 Lac Tonnes in FY'23 with a capacity utilisation of 97%.
5. Renewable Energy share in the Total Power consumption increased from 46% during FY' 22 to 48% during FY' 23.
6. UCWL has created Renewable Energy Portfolio of more than 21 MW which is equal to its Contract demand.

Commenting on the Results of the Company, **Mrs. Vinita Singhania, Chairperson** of the Company said “*despite considerable pressures on the margins on account of the unabated increase in the fuel cost, the Company has been able to record satisfactory performance by improving its various Efficiency parameters & better the Product Mix & Geo Mix*”.

## **SUSTAINABILITY**

During the Current Quarter, the Company has successfully commissioned the first of its kind in the State of Rajasthan & the only one in the entire Indian Cement Industry a Floating Solar Power Plant of 1 MW. This has resulted in the increase in the Share of Total Renewable Energy of the Company to 48% of its Total Power requirement.

## **CAPEX**

Work on the Expansion Project of 2.50 Million Tonnes Cement Plant is on full swing as per Schedule. The Project is expected to be commissioned in the Second Quarter of FY25 as per the Original Schedule. The Clinkerisation Line of 1.50 Million Tonnes Per Annum is expected to be commissioned ahead of the Schedule during the Third Quarter of FY24.

## **RIGHTS ISSUE**

The Company proposes to go for the Rights Issue of upto Rs.450 Crores to part-finance its on-going Cement Expansion Project in June / July 2023.
