**Kolkata, July 02, 2025:** Baazar Style Retail Limited (BSRL), one of the leading value fashion retailers in Eastern India, reports its business update for the quarter ended June 30, 2025.

#### Key Highlights:

- Standalone Revenue from Operations posted a strong growth of **37% YoY to Rs 3,777 Mn** in Q1 FY26.
- Sales Per Square Feet (PSF) stood at Rs 664 per month in Q1 FY26.
- Total No. of Stores stood at **232** and the Total Rental area stood at **21.13 Lakh Sq Ft**, as of June 30, 2025. The Company opened a total of **22** new stores and closed **4** stores during Q1 FY26.
