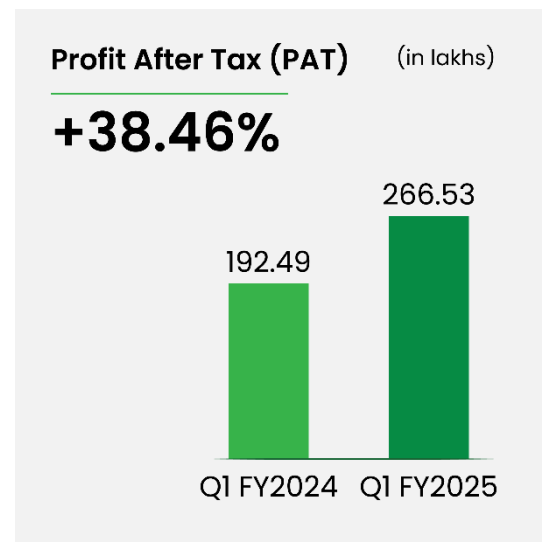
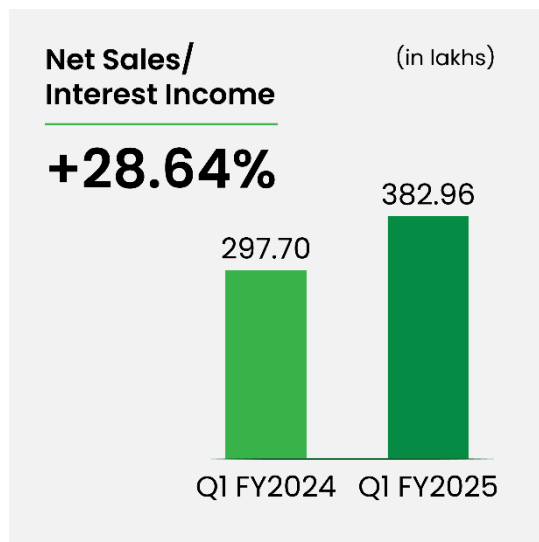
### PROFIT AFTER TAX INCREASES BY 38.46% ON A YOY BASIS

#### Key Financial Highlights (Standalone - Q1 FY2025 vs Q1 FY2024):

- Total Income grew by 8.82% YoY to ₹436.99 lakh (Q1 FY24: ₹401.58 lakh)
- Net Sales / Interest Income rose by 28.64% YoY to ₹382.96 lakh (Q1 FY24: ₹297.70 lakh)
- Profit After Tax (PAT) increased sharply by 38.46% YoY to ₹266.53 lakh (Q1 FY24: ₹192.49 lakh)
- Profit Before Tax (PBT) stood at ₹317.26 lakh, up by 18.01% YoY (Q1 FY24: ₹268.84 lakh)
- Total Expenditure declined to ₹119.72 lakh, compared to ₹132.74 lakh in Q1 FY2024, reflecting operational efficiency
