## October - December 2020 (Third Quarter)

Total revenue from operations (net) for the quarter was INR 28,287.18 Lakh, showing an <u>increase of</u> <u>16%</u> as compared to the corresponding quarter of 2019. Total Revenue for Nine Month period ending 31 December 2020 stood at INR 79,822.58 Lakhs.

PBT for the quarter was INR 3,113.11 Lakh as compared to INR 851.97 Lakh showing an <u>increase of</u> <u>265%</u>. PBT for the Nine Month period ending 31 December 2020 stood at INR 10,718.89 Lakh compared to INR 4,956.56 lakhs for the corresponding Nine Month period in 2019 showing an increase of 116%.

Net Profit for the quarter after tax was INR 2304.32 Lakh as compared to INR 614.92 Lakh in the corresponding quarter of 2019 showing an **increase of 275%**. Net Profit for the Nine Month period ending 31 December 2020 stood at INR 7,976.64 Lakh compared to INR 4,243.79 lakhs for the corresponding Nine Month period in 2019 showing an increase of 88%.

### Performance Highlights

The company, one of the leading Building material solution provider, has posted highest ever profits during the nine months period ended 31-12-2020. The Building Products business segment led the Company's strong quarterly performance. Building Products had reported Segment Revenue of INR 23,577.80 Lakh as compared to INR 18,848.60 Lakh in the corresponding quarter of 2019 and the segment Profit Before Tax stood at INR 3,902.19 Lakh.
