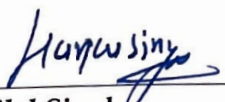

ITEM NO. 2:

Re-appointment of Mr. Harilal Singh (DIN: 05124923) as a Wholetime Director of the Company for a further period of 3 years:

Mr. Harilal Singh was appointed as Whole-Time Director of the Company w.e.f 6th August, 2025 pursuant to provisions of Section 196, 197, 203, Schedule V and any other applicable provisions, if any, of the Companies Act, 2013.

The Board at their meeting held on 6th August, 2025 based on the recommendation of the Nomination and Remuneration Committee in accordance with provisions of Sections 196, 197, 203, Schedule V and other applicable provisions, if any, of the Companies Act, 2013 read with Companies (Appointment and Remuneration of Managerial Personnel) Rules, 2014 including any statutory modification(s) or re-enactment(s) thereof for the time being in force) subject to approval of Shareholders at the ensuing Annual General Meeting approved Re-Appointment and remuneration to be paid to Mr. Harilal Singh as Whole-Time Director of the Company for a period of Three years from August 6, 2025 to August 5, 2028.

Mr. Harilal Singh presently is the Whole-Time Director of the Company and looks after the entire business operations of the Company.
 - h. Past remuneration : Nil
 - i. Recognition and awards : Nil
 - j. Job profile and suitability : He has the educational background, training and experience suitable for the job.
 - k. Comparative remunerative profile in the industry : The salary proposed is within the ambit of Schedule V of Companies Act, 2013 and is comparable with the remuneration provided in the Industry.
 - l. Pecuniary relationship with the company : Mr. Harilal Singh holds nil equity shares of the Company, thus there is no pecuniary relationship with the company.

III. Other information:

- 1. Reasons for inadequacy of profits : The profits as calculated under the managerial remuneration to directors under the Companies Act 2013 are inadequate for payment of remuneration. The scale and activity of the company's operations are growing. With a view to adequately compensate the directors as per current industry standards, the remuneration is constituted appropriately.
- 2. Steps to be taken for improving : The company's operations are growing over each year. The profits in future years will be adequate to cover the remuneration.
- 3. Expected increase in profits and productivity : The Company anticipates a growth in the Business and consequently the Profits of the Company. The Company does not ascertain a numerical figure however is hopeful of growth opportunities.

IV. Perquisites:

Mr. Harilal Singh as a Whole-Time Director cum CFO will be entitled for following perquisites, which shall not be part of the ceiling of remuneration:

- d. Holiday passage for children studying outside India/family staying abroad : Return holiday passage once in a year by economy class or once in two years by first class to children and to the members of the family from the place of their study or stay abroad to India if they are not residing in India with the managerial person.
 - g. Leave travel concession : Return passage for self and family in accordance with the rules specified by the Company to any destination in India.
 - f. Leave encashment : Encashment of leave at the end of the tenure
- V. Salary and perquisites specified herein shall be payable to the Whole-Time Director notwithstanding the inadequacy or no profits in any financial year during the currency of tenure of his office as such.
- VI. The Whole-Time Director shall not be paid any sitting fee for attending the meetings of the Board of Directors or committee thereof.
- VII. The Whole-Time Director shall not become interested or otherwise concerned directly or through his wife or minor children in any selling agency of the Company as per the provisions of the Law in force as applicable to the Company.
- VIII. The terms and conditions of the said re-appointment may be altered and/or varied from time to time by the board as it may, in its discretion, deem fit so as not to exceed the limits specified in Schedule V of the Companies Act, 2013, or any amendment hereafter in that regard.

Terms & Conditions relating to Re-Appointment will be available for inspection at the registered office of the Company during normal working hours.

Mr. Harilal Singh satisfies all the conditions as set out in part I of Schedule V as also under sub-section 13 of Section 196 of the Companies Act, 2013 for being eligible to be appointed as a Whole-Time Director of the Company. However, Board in its meeting held on 6th August, 2025, based on the recommendation of Nomination & Remuneration Committee. and subject to the approval of the Members of the Company, appointed Mr.

Nikunj Pancholi as an Additional Director effective 6th August, 2025, in the capacity of Non-Executive Non-Independent Director on the Board of the Company, liable to retire by rotation.

The Company has received requisite consent and declarations from Mr. Nikunj Pancholi in accordance with the provisions of the Companies Act, 2013 ('the Act') and as per SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, ('SEBI Listing Regulations'). He is neither disqualified from being appointed as Director in terms of provisions of the Act nor debarred from being appointed to the office of Director by virtue of any order of SEBI or any such other authority. A notice in writing in the prescribed manner as required pursuant to Section 160 of the Act, as amended and the Rules made thereunder has been received by the Company, concerning the appointment of Mr. Nikunj Pancholi as a Non-Executive Non-Independent Director of the Company.

The profile and other relevant information as required under the LODR Regulations and SS-2 are provided in additional information section of this Notice.

Based on the recommendation of the Nomination & Remuneration Committee, the Board of Directors of the Company recommended the appointment of Mr. Nikunj Pancholi as Non-Executive Non-Independent Director of the Company, liable to retire by rotation, as a Special Resolution as set out at Item No. 3 of this Notice before the Members for their approval.

None of the Directors, Key Managerial Personnel of the Company or their relatives except Mr. Nikunj Pancholi is, in any way, concerned with or interested, whether financially or otherwise, in the resolution as set out in the Notice, in so far as it concerns his appointment and payment of remuneration as a Non-Executive Non-Independent Director.

The Securities and Exchange Board of India (SEBI) vide its Notification dated 12 December, 2024, has made several changes in SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations"). As per requirements of amended provisions of Regulation 24A of the SEBI Listing Regulations read with the provisions of Section 204 of the Companies Act, 2013 ('the Act') and related Rules, the Board of Directors of the Company, based on the recommendation of the Audit Committee, has recommended appointment of M/s. HSPN & Associates LLP, (Peer Review No. 6035/2024, FRN: L2021MH011400) Practising Company Secretaries, as the Secretarial Auditors of the Company for a term of 5 (five) consecutive years commencing from 01st April, 2025 upto 31st March, 2030. The proposed fee to be paid to M/s. HSPN & Associates LLP will be determined by the Board of Directors of the Company in consultation with the said Secretarial Auditors and as per the recommendations of the Audit Committee.

M/s. HSPN & Associates LLP is a reputed firm of Practising Company Secretaries with 30 years of firm experience. The firm has a diverse clientele across several industries. Their audit approach and fee structure have been evaluated and found to be appropriate, aligning well with the Company's requirements. M/s. HSPN & Associates LLP have consented to act as Secretarial Auditor and have furnished a certificate confirming that that they are not disqualified to be appointed as Secretarial Auditor under the provisions of the Act and SEBI Listing Regulations read with SEBI Circular dated 31st December 2024. The Board commends the Ordinary Resolution at Item No. 5 of the Notice for approval by the Members. None of the Directors or Key Managerial Personnel of the Company or their respective relatives are concerned or interested in the Resolution at Item No. 4 of the accompanying Notice.

Ms. Renu Manendra Singh (DIN: 00860777) was appointed as an Additional Independent Director with effect from 10th December, 2024, in accordance with the provisions of Section 161 of the Companies Act, 2013 read with the Article of Association. Pursuant to Section 161 of the Companies Act, 2013, the above Director holds office up to the date of ensuring Annual General Meeting of the Company. The Board is of the view that the appointment of Ms. Renu Manendra Singh (DIN: 00860777) on the Company Board is desirable and would be beneficial to the Company and hence it recommends the said resolution no. 3 for approval by the members of the Company. None of the Directors/Key Managerial Personnel of the Company/their relatives except Mr. Mukesh Kumar Seni (DIN: 10998990) himself, in any way concerned or interested, in the said resolution. The Board recommends the said resolution to be passed as Special Resolution.

As per Section 149(10) of the Act, an Independent Director shall hold office for a term of upto five consecutive years on the Board of a Company, but shall be eligible for re-appointment on passing a special resolution by the Company for another term of upto five consecutive years on the Board of a Company.

Based on recommendation of Nomination and Remuneration Committee and in terms of the provisions of Sections 149, 150, 152 read with Schedule IV and any other applicable provisions of the Act and the Listing Regulations, Ms. Renu Manendra Singh, being eligible for appointment as an Independent Director and offering herself for appointment, is proposed to be appointed as an Independent Director for a term of five consecutive years from 10th December, 2024 upto 9th December, 2029.

Ms. Renu Manendra Singh is 40 year old, holds Bachelor's Degree in BA. in Bachelor of Arts from Shri Radha Rani Degree College Julahpur. She Posses a diverse and wide ranging experience and knowledge of Corporate Affairs has been associated as Independent / Non Executives Directors for several public companies.

Accordingly, the Board recommends Special Resolution in relation to eligibility appointment of Ms. Renu Manendra Singh as a Non-Executive Independent Director for term of five consecutive years with effect from 10th December, 2024 upto 9th December, 2029, for the approval by the shareholders of the Company.
