**Wednesday 24<sup>th</sup> July, 2019, Mumbai :** The Board Meeting of Shriram Transport Finance Company Limited (STFC), one of the largest asset financing NBFCs in the country, was held today to consider the unaudited financial results for the first quarter ended 30<sup>th</sup> June, 2019.

### **Financial ( Standalone)**

#### **First quarter ended 30<sup>th</sup> June, 2019 :**

The Net Interest Income for the first quarter ended 30<sup>th</sup> June, 2019 increased by 7.62% at Rs. 1,961.74 crores as against Rs. 1,822.89 crores in the same period of the previous year. The profit after tax increased by 10.71% at Rs. 634.25 crores as against Rs. 572.90 crores recorded in the same period of the previous year. The earning per share (basic) for the first quarter ended 30<sup>th</sup> June, 2019 increased by 10.73% at Rs. 27.96 as against Rs. 25.25 recorded in the same period of the previous year.

#### **Assets under Management :**

Total Assets under Management as on 30<sup>th</sup> June, 2019 stands at Rs. 106,343.48 crores as compared to Rs. 100,540.57 crores as on 30<sup>th</sup> June, 2018.
