

Q2 & 1H FY2017 Key Developments



Key Developments:

- Income from Operations jumps almost six-fold to Rs. 206 crores in Second-Quarter FY2017.
- Income from Operations jumps almost eight-fold to Rs.731 crores in First-Half FY2017.
- EBITDA jumps to Rs. 126 crores in Second-Quarter FY2017 v/s Rs. 10 crores in Second-Quarter FY2016.
- EBITDA jumps to Rs. 241 crores in First-Half FY2017 v/s Rs. 28 crores in First-Half FY2016.

Demonetization: Short-term pain but Long-term gain



- Improved transparency in the sector.
- More confidence in the minds of home buyers with regards to fair transactions and on-time execution of projects.
- Increased deposits in the banking system will push down home loan rates leading to increase in demand.
- Sector should witness substantial inflow of foreign capital via private equity and REITs.
- Demand from consumers in the luxury segment largely inelastic as consumer prefers completed/Ready to move in projects.
- The step will be **well supported by other recent reforms** undertaken by the Government in the real estate sector **like Real Estate Regulation Act (RERA).**


