

## Motherson Sumi Systems Ltd. posts “Highest Ever Quarterly Revenue of INR 16,234 crores” up by 14%, EBITDA is up by 13%

The company posted quarterly consolidated revenues of INR 16,234 Cr. and consolidated EBITDA of INR 1,415 Cr. These results compare to revenues of INR 14,271 Cr. and EBITDA of INR 1,249 Cr in the same quarter in the previous year.
