Ganesha Ecoverse Announces HY1FY26 Consolidated Financial and Operational Performance

Kanpur, November 15, 2025 — Ganesha Ecoverse Limited is pleased to announce its consolidated financial results and performance of its Associate, GESL Spinners Private Limited (GSPL), for the half year ended September 30, 2025.

Financial Highlights (Standalone – Ganesha Ecoverse Ltd)

- **Total Income:** ₹57.69 Lakh
- **Loss After Tax:** ₹129.83 Lakh

The above loss is mainly on account of MTM loss adjustment amounting to Rs. 149.48 Lakh to reflect the fair value of the Company's current investments in equity shares of the Company due to market slowdown.

- **Total Income:** ₹57.69 Lakh
- **Loss After Tax:** ₹612.03 Lakh

Financial Highlights (Associate Company – GESL Spinners Private Limited)

- **Loss After Tax:** ₹1,086.28 Lakh
- **Production Quantity:** 3,756 MT

In August 2024, the yarn spinning facility of GSPL suffered extensive damage due to a severe storm and flooding, leading to a temporary operational halt for a significant period of time. After this unforeseen setback, the Associate Company has fully resumed operations and has crossed more than 80% capacity utilization in September, 2025 and expected to improve further in coming months.

Recognizing the strategic importance of GSPL in strengthening the Company's textile and recycled fibre portfolio, the Board of Directors, at its meeting held on May 30, 2025, approved the proposal for the merger of GSPL with the Company.
