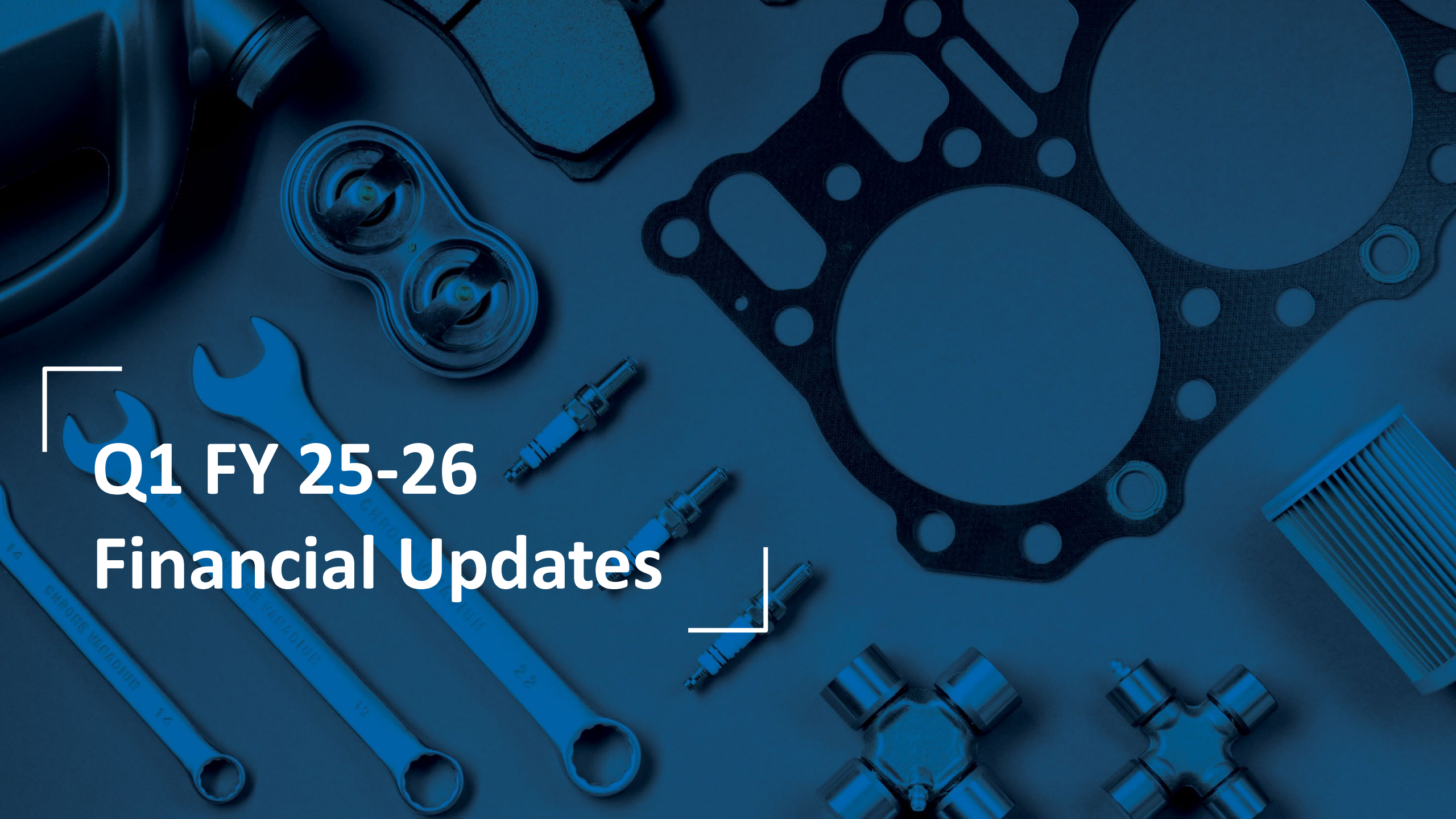

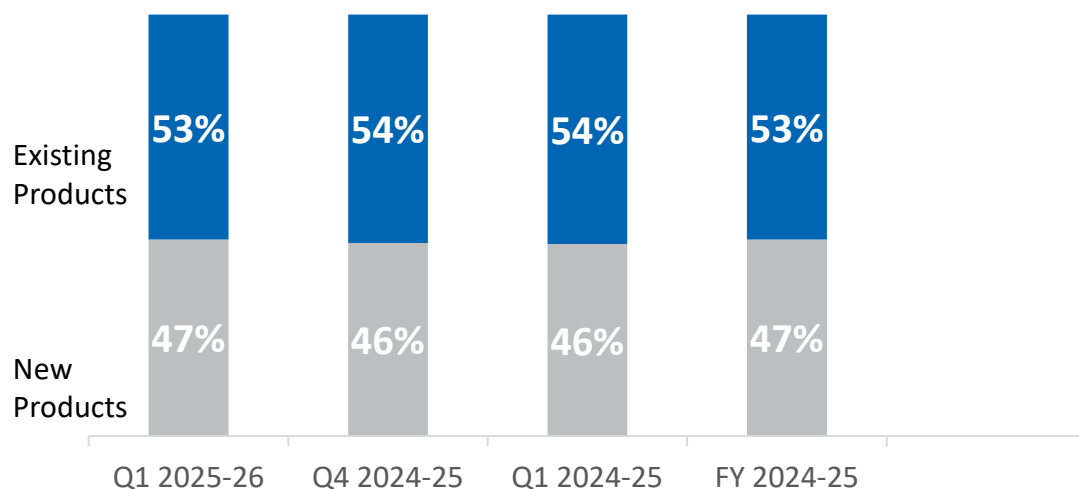

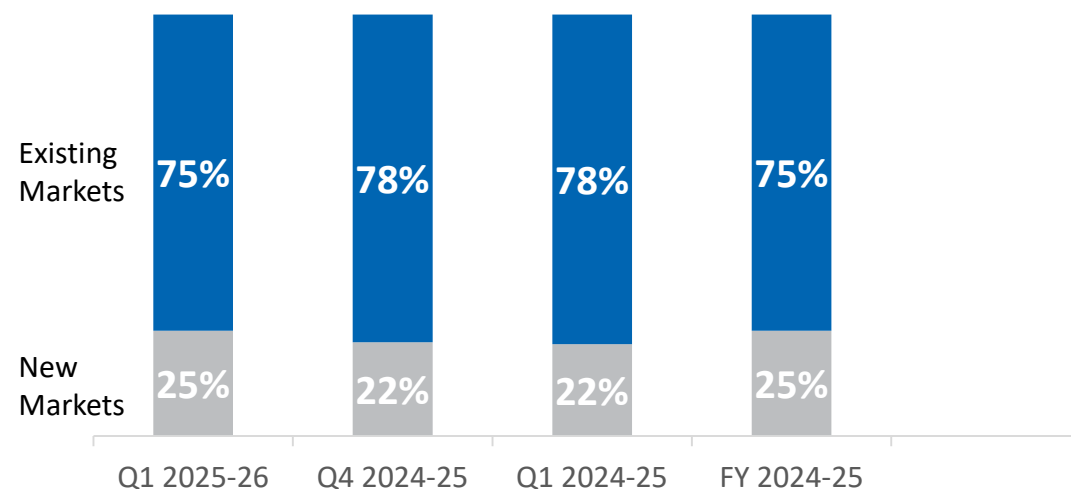


Product Mix

We are pleased to announced that our New U Bolt Plant at Indore has Commenced Operations and we made first supply in July-2025

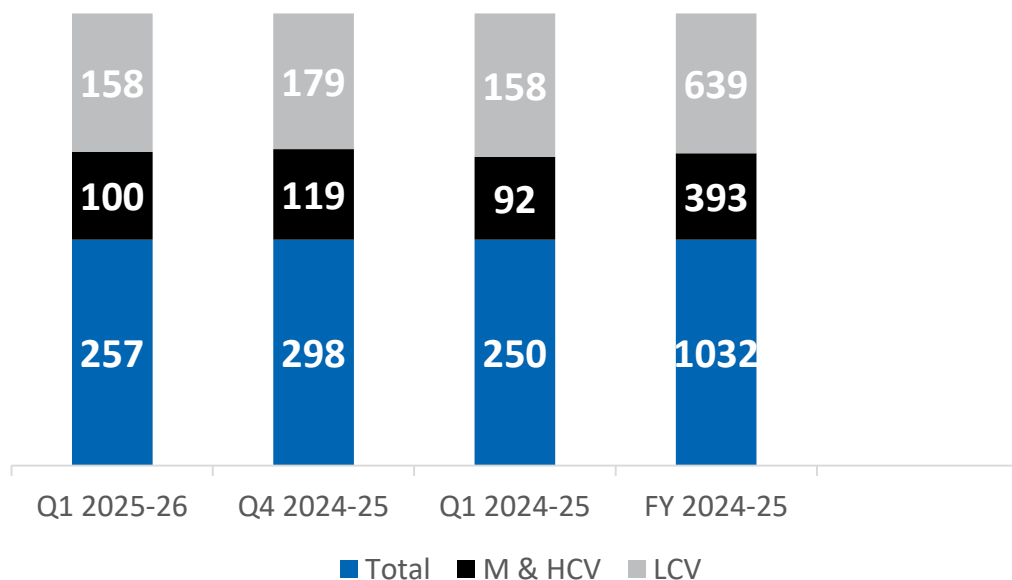

Jai's Plants : Strategically Located Across OEM Plants

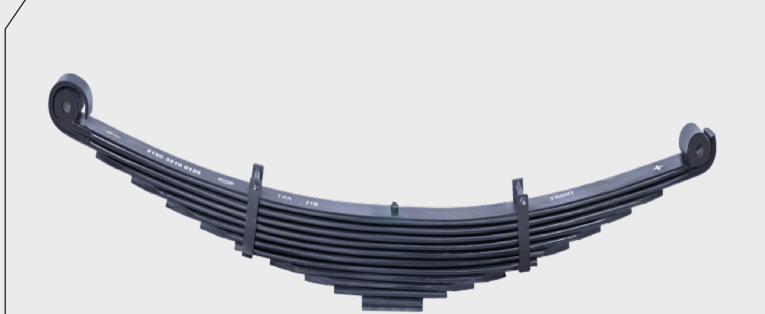

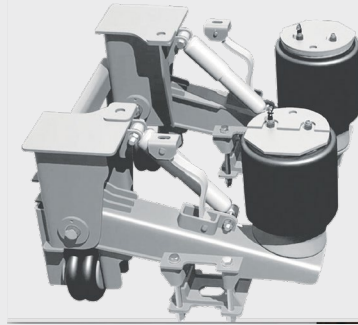

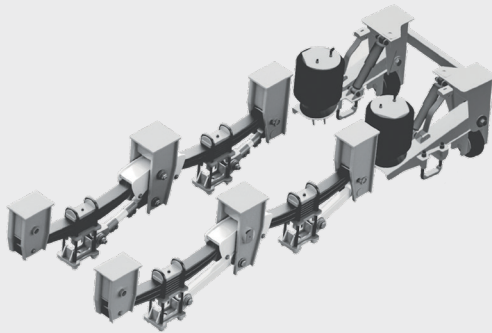

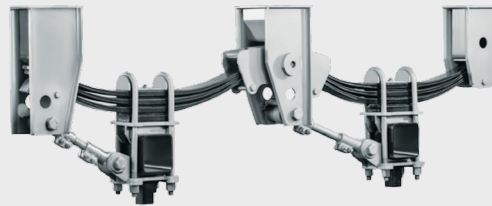

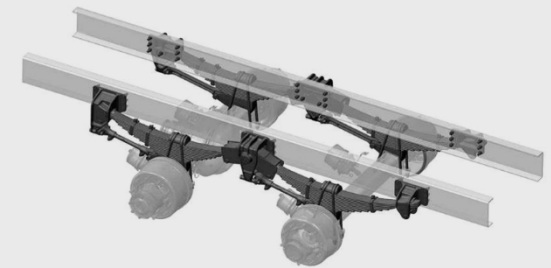

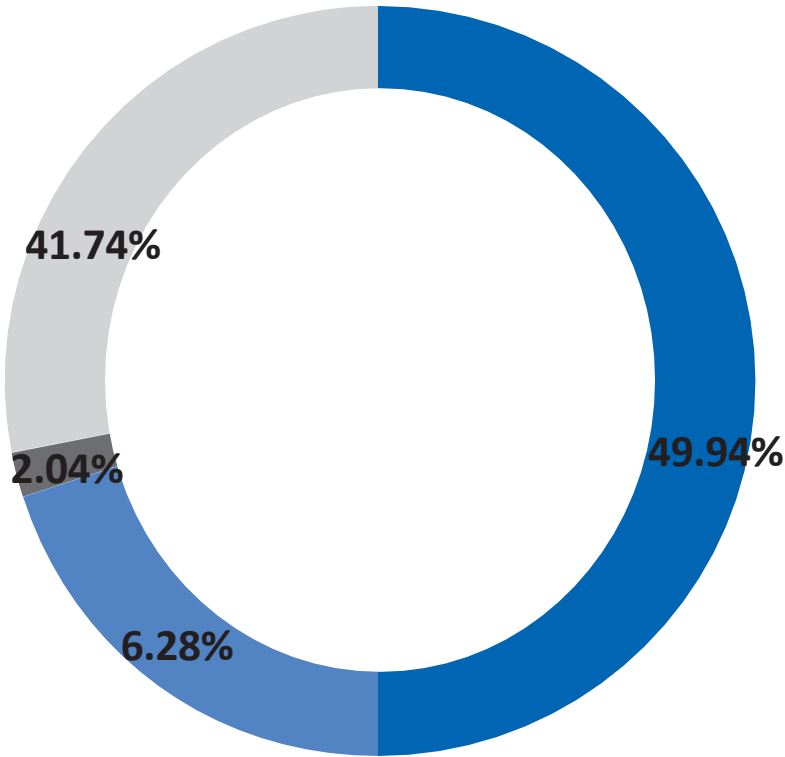
