





# 2. Strong Order Book Fuelling Revenue Growth (1/3)



- ➤ Current Order Book (EPC) at Rs. 584 crore; of this, Rs. 150–200 crore worth of projects are expected to be completed within 2 years
- ➤ Order Inflow Momentum: Rs. 250 crore in 2–3 months is a significant addition, potentially doubling the current executable pipeline
- > Strong Bid pipeline tender to be opened in next six months
- ➤ Order Book is dominated by **government projects**, ensuring better execution certainty and payment security
- ➤ Plan to maintain a **balance mix** of EPC and Tollway projects to diversify cash flows, supporting sustained revenue growth
