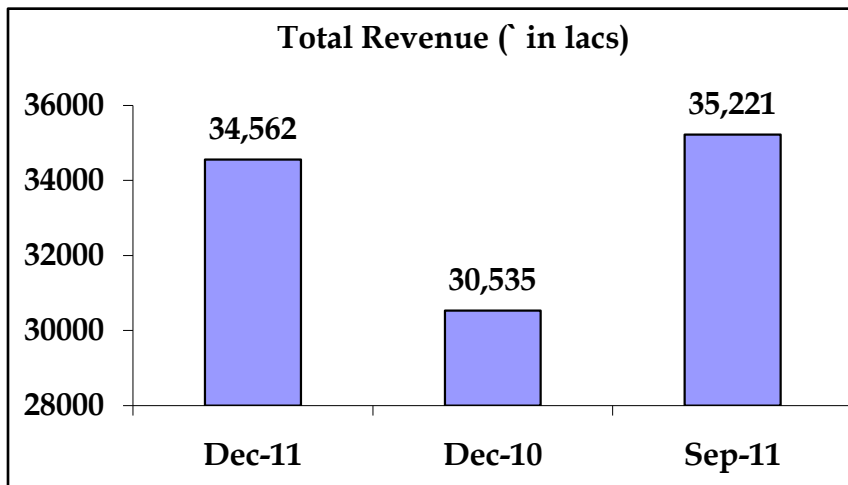

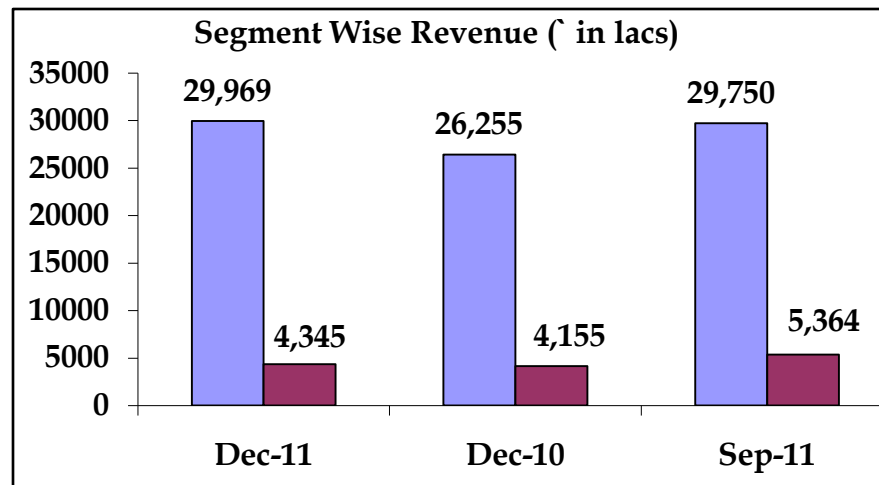

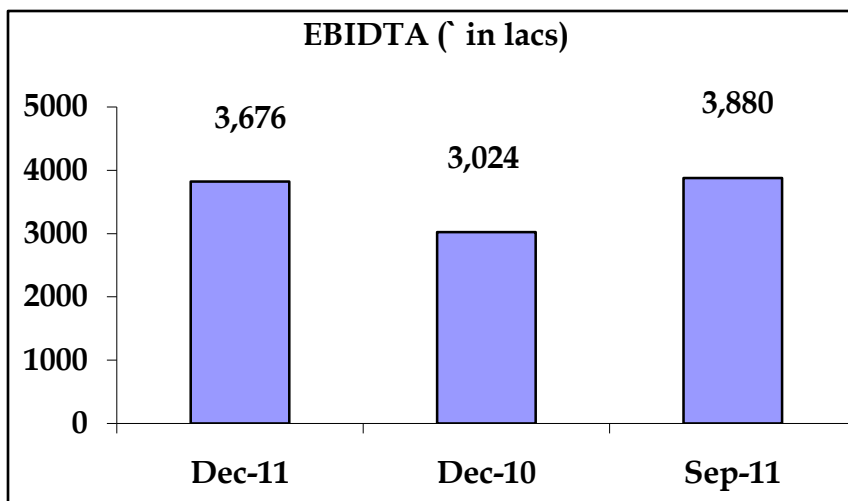


YoY Growth : 13%; QoQ Growth : -2%

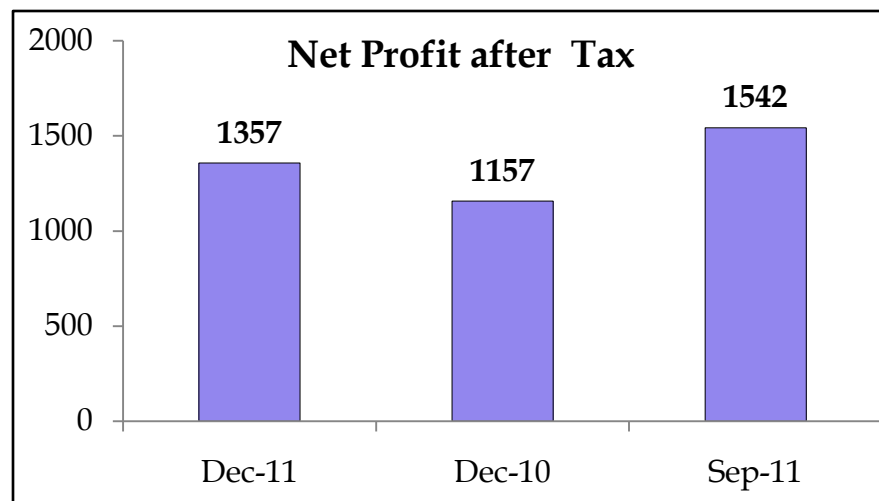


Plastics YoY Growth : 14%; QoQ Growth :-1%

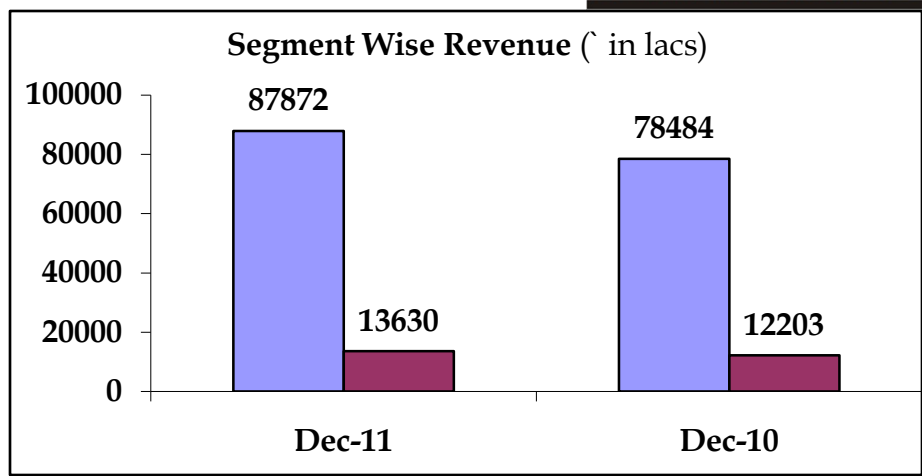
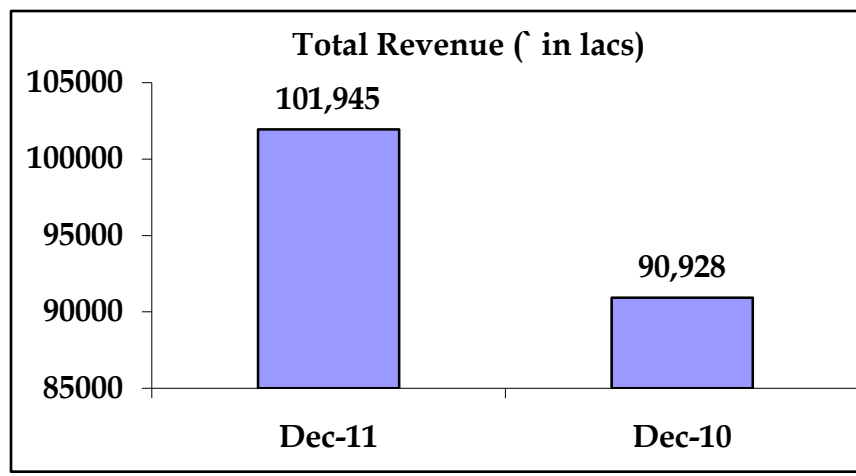
Retail YoY Growth : 5%; QoQ Growth : -19%

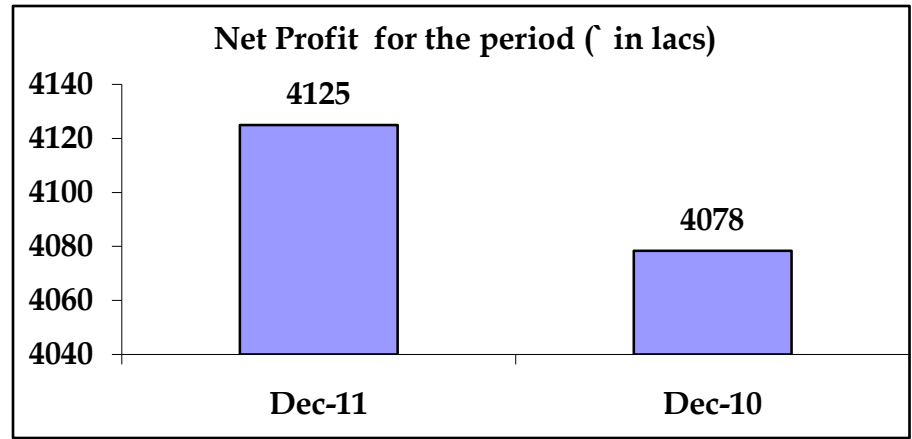
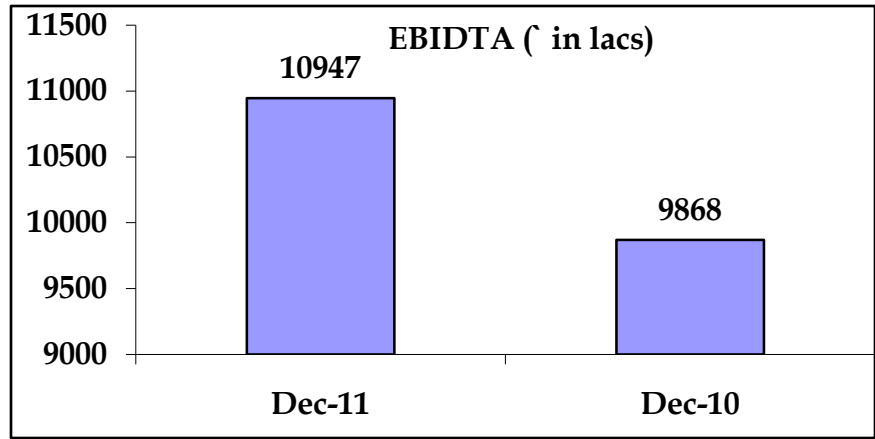


YoY Growth : 17%; QoQ Growth : -12%

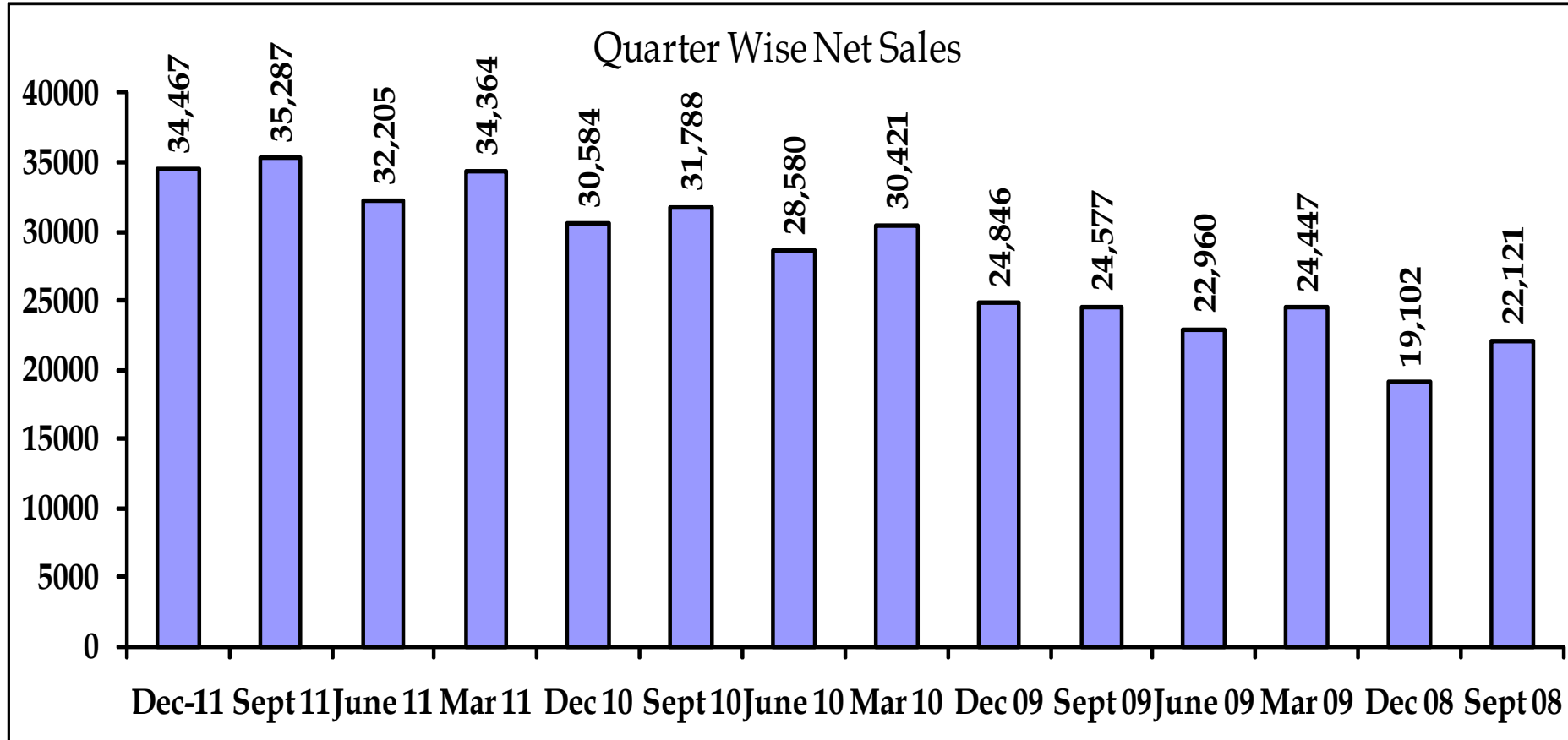

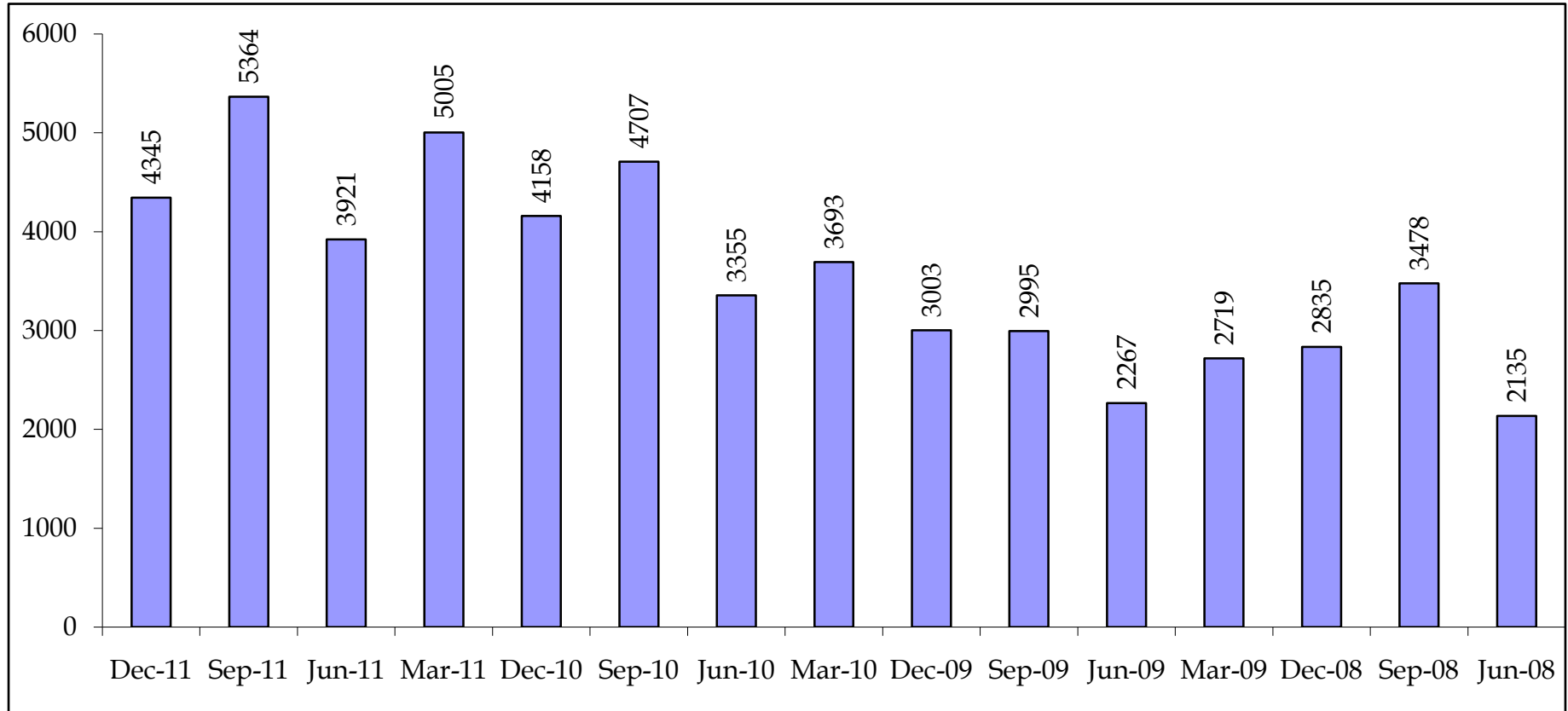

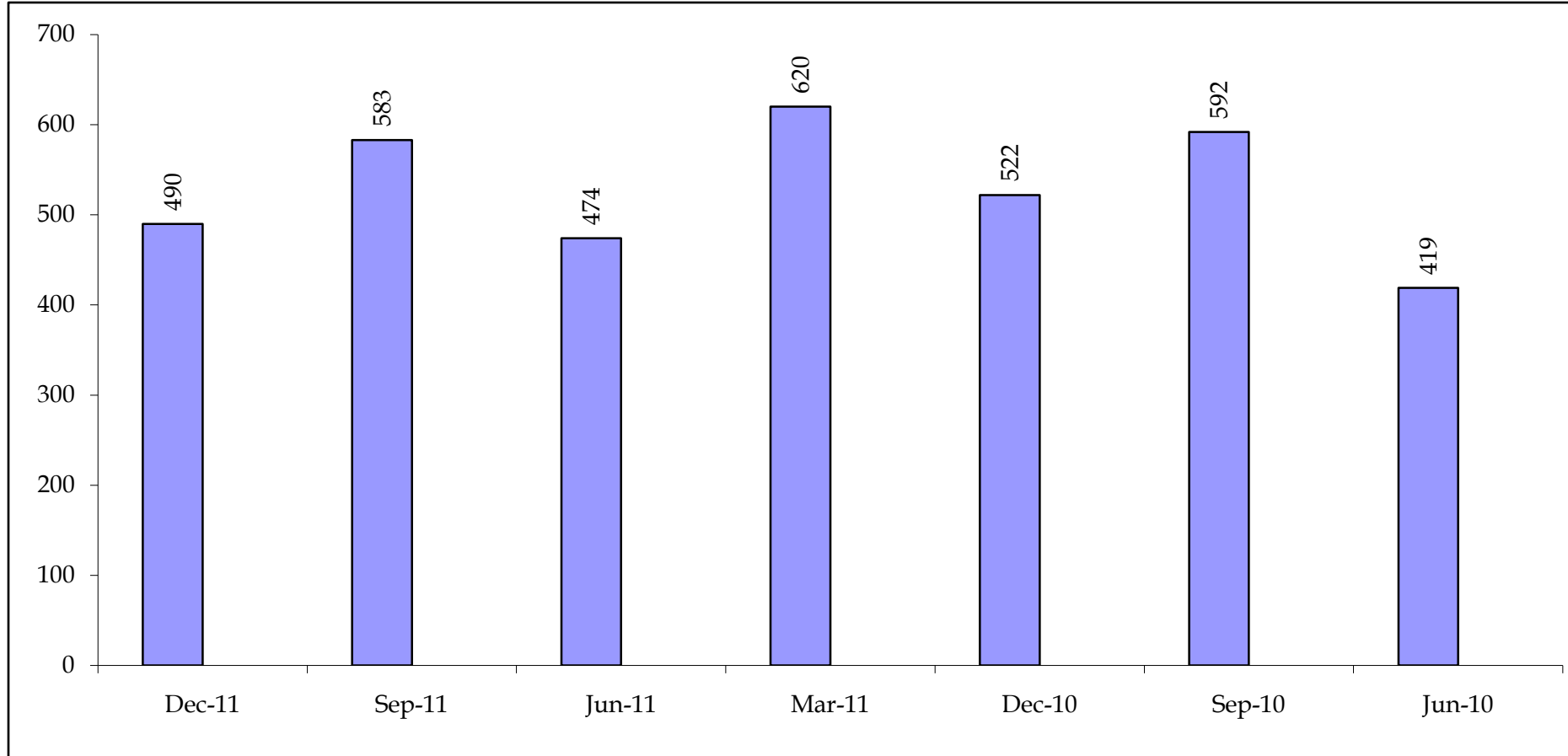

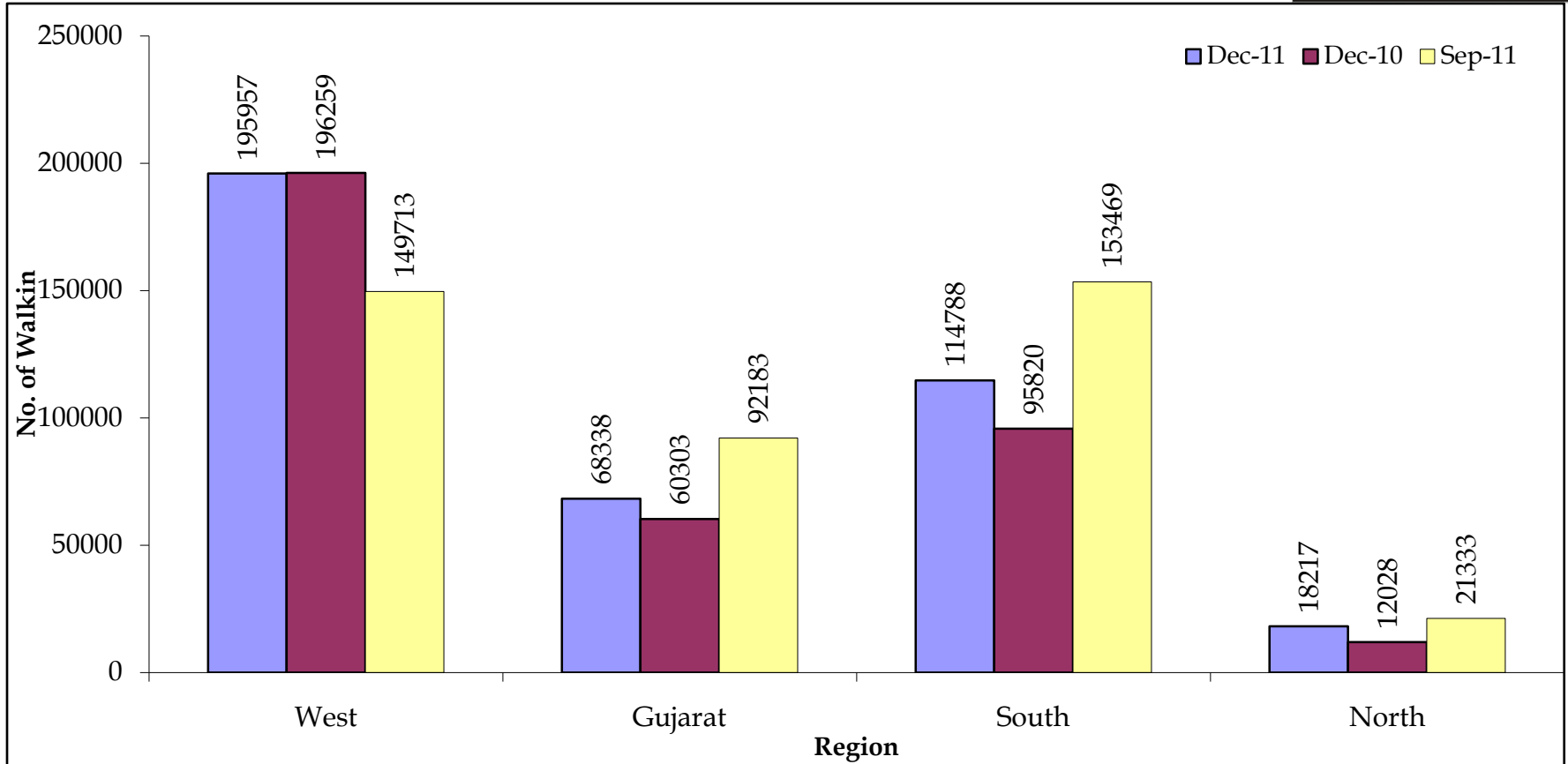

Region Wise Quarter Wise Walkin



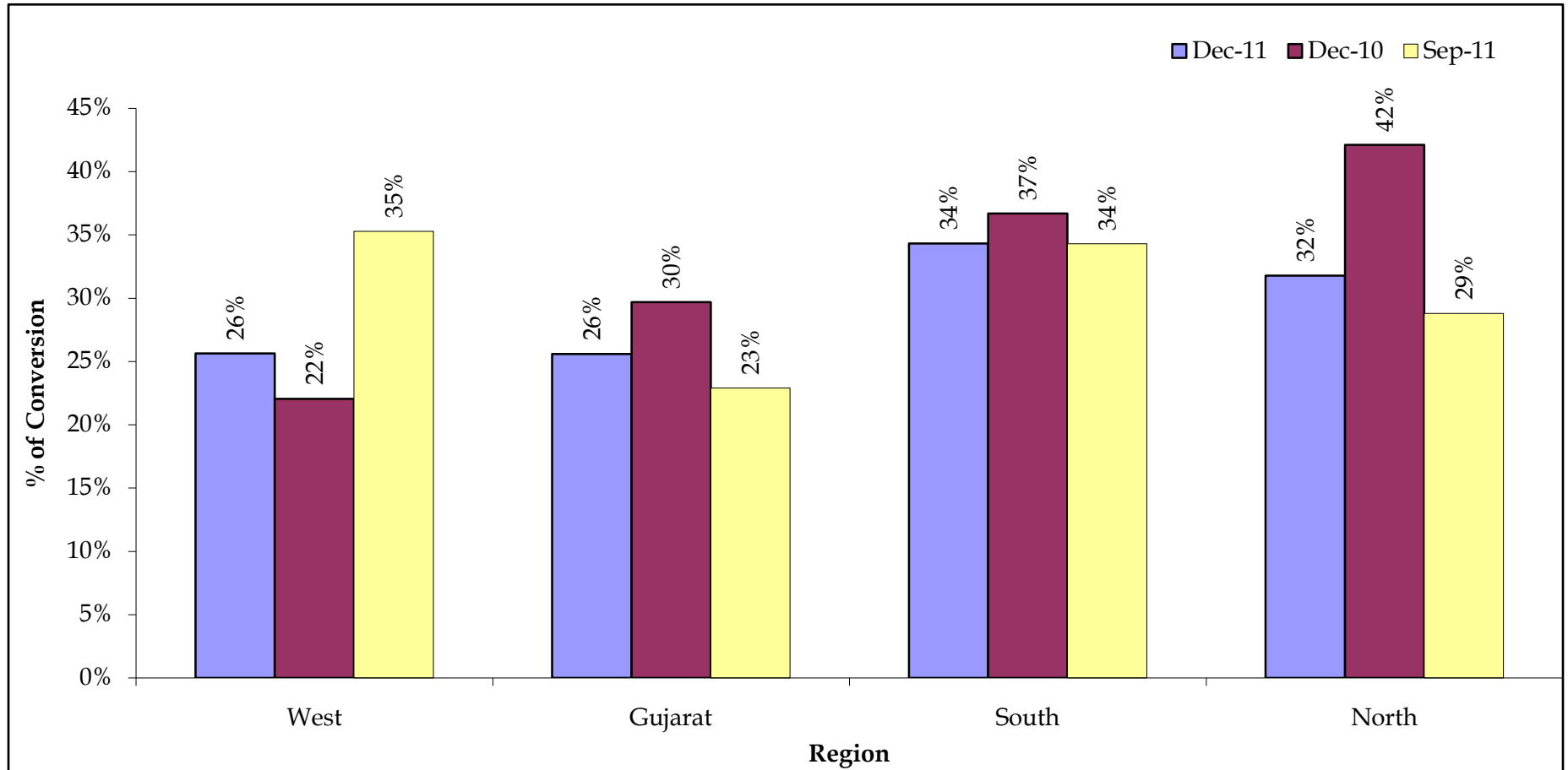
