FINANCIAL PERFORMANCE AND ANALYSIS

- During the quarter ended June 30, 2019, RIIL achieved Total Income of ₹ 2,432 lakh as compared to ₹ 2,494 lakh achieved in the corresponding period of the previous year.
- During the Quarter ended June 30, 2019:
 - o Income from Product Transportation Service increased from ₹ 775 lakh to ₹ 780 lakh as compared to corresponding period of previous year.
 - o Income from Hiring Construction Machineries decreased from ₹ 518 lakh to ₹ 401 lakh as compared to corresponding period of previous year.
 - o Income from Other Support Services increased from ₹ 827 lakh to ₹ 856 lakh as compared to corresponding period of previous year.
- Net Profit during the quarter ended June 30, 2019 was ₹ 172 lakh as compared to ₹ 192 lakh of corresponding period of previous year.







RIIL continues to provide infrastructure support services namely transportation of petroleum products and water through pipelines, construction machinery on hire, and other support services to Reliance Industries Group, with a substantial portion provided to Reliance Industries Limited.

RIIL presently does not have any expansion plans on the anvil.
