This is also a reminder to update your KYC details pursuant to SEBI Master Circular No. SEBI/HO/MIRSD/POD-1/P/CIR/2024/37 dated 7th May 2024, and to dematerialise your physical securities. The circular issued by SEBI mandates all listed companies to record PAN, address with PIN code, mobile number, bank account details, specimen signature, and choice of nomination for all security holders holding securities in physical mode. While updating the email ID is optional, security holders are encouraged to register their email address to avail online services.

The formats for Nomination and KYC updation, viz.: Forms ISR-1, ISR-2, ISR-3, SH-13, SH-14 and SEBI circulars are available on the RTA's website:

The aforesaid SEBI circular also mandates that security holders holding securities in physical mode, whose folios do not have PAN, nomination, contact details, bank account details, and specimen signature updated, shall be eligible for any payment, including dividend, interest, or redemption, only through electronic mode with effect from 1st April 2024.
