## Outcome of the Board of Directors' Meeting

In its meeting held on November 04, 2019, the Board of Directors approved the Q2 FY2019-20 results of the Company.

Total income for the Quarter under review is Rs. 305.65 Crores compared to Rs. 280.86 Crores in the corresponding quarter of the previous year and for Half-year at Rs. 503.94 Crores compared toRs. 503.90 Crores respectively of same period a year ago.
