## 1. Updation of KYC and other matter:

As per SEBI Master Circular No. SEBI/HO/MIRSD/POD-1/P/CIR/2024/37 dated May 07, 2024, shareholders holding securities in physical mode are required to update their KYC details including PAN, address with PIN code, mobile number, bank account details, specimen signature and choice of nomination (email ID is optional but recommended) and also dematerialise their holdings; failing which, with effect from April 1, 2024, they shall be eligible to receive payments such as dividend, interest or redemption only through electronic mode.
