Hariom Pipe Industries Reports Revenues of INR 14,264.21 Lakhs and PAT of INR 953.75 Lakhs for Q1FY'23

Hariom Pipe Industries Ltd., at its board meeting held on 10th August, 2022 declared its financial performance for the first quarter ending 30th June 2022, of the financial year 2022 – 23. The following is the key financial performance:

Commenting on the performance of the company, Mr. Rupesh Gupta, Managing Director said "we are very satisfied with the performance during this quarter as the company's sales of ERW Steel Pipes by volume grew 28% over the previous quarter ending 31st March 2022 and grew 49% over the last year quarter ending 30th June 2021. The June 2022 quarter has been turbulent for the industry as the commodities like iron ore, coal etc., have been highly volatile and the energy costs remained high. Despite such volatility and a downward price slide in steel, Hariom continued the growth momentum and also expanded its footprint further in the Southern India. During the quarter, the company worked on expanding its management bandwidth by hiring high quality talent, strengthened & enhanced its marketing and sales team and have added dealers & retailers. We have been carrying out a vigorous brand building program in South India and have started to witness a very positive outcome of the same. The company's EBITDA per ton for the ERW Steel Pipes remains healthiest in the industry"

Mr. Rupesh Gupta further added "we are seeing a much stable current quarter in terms of commodity prices stabilizing. Monsoon period is a relatively slower one as the construction and infra sector activity slows down to a considerable extent. We are excited on the foreseeable future with the outlook of a vibrant infrastructure and construction activity across the country post the monsoon season. The company is in the midst of executing its ERW Steel pipe mills expansion and modernization capex as set out in the prospectus during its maiden IPO. The company is also implementing the cold rolled steel mill and galvanized pipe mill projects.
