Pfizer Limited revenue up by 8% for the Quarter ended December 31, 2015

February 3, 2016: Pfizer Limited reported a revenue growth of 8% for the third quarter ended December 31, 2015. Revenue growth has been driven by double digit performance on a number of key brands offset by relatively soft growth on a couple of products.

Q3 Profit before Tax & Exceptional items

Profit before tax and exceptional items at Rs. 75 Cr in Q3, 15-16 grew by 65% as compared to Rs. 45 crore for the previous period on account of one off expenses in the previous year.

EBITDA

EBITDA for Q3 is at 16.2% on account of higher one off expenses. Profit from operations for the quarter at Rs. 50.6 crores grew by 79% as compared to the previous period.
