Highlights:

Results for the quarter and nine months ended 30th September, 2016 are not entirely comparable with the results of the corresponding period/s due to MAGGI Noodles issue in 2015 and rebuild of the MAGGI Noodles business in 2016.

- **Net Sales** for the quarter increased by 35.1% on a base impacted by MAGGI Noodles issue. While Domestic Sales increased by 37.9%; Exports increased by 5.1%.
- Net Profit at Rs. 269 Crores for the quarter has increased from Net Profit of Rs. 124 Crores in the same period in 2015.
