


Natural Gas Transmission (MMSCMD)



Natural Gas Marketing (MMSCMD)









Natural Gas: Source-wise Bifurcation















Natural Gas Marketing - Sector Wise Supply











Gross Margin (EBITDA)




Financial Performance (Consolidated Basis)








Gross Margin (EBITDA)








Capital Expenditure Profile




