# Gati Q3 Income up by 21% to Rs.2288 mn

**Hyderabad, Andhra Pradesh, April 30, 2011:** Gati Ltd, India's leader in Express Distribution and Supply Chain Solutions today announced its third quarter and nine months ended results as on 31<sup>st</sup> March 2011 at its Board Meeting held in Hyderabad.

The company posted a total income of Rs 2288 mn in the third quarter as compared to a total income of Rs.1894 mn for the corresponding quarter of the previous year, thereby registering a growth of 21% in revenue. EBITDA grew by 23% at Rs. 250 mn as compared to Rs. 203 mn in the corresponding quarter of the previous year.

The Consolidated revenues registered a significant growth of 32.3% from Rs.6929 mn to Rs.9164 mn for the nine months ended 31<sup>st</sup> March 2011 over the corresponding period last year.

# **Divisional Performance**

Express Distribution & Supply Chain Division has shown a robust growth in revenue of 23% to Rs.2025 mn compared to a revenue Rs.1643 mn and a 34% growth in EBITDA to Rs. 213 mn as compared to Rs. 159 mn for the corresponding quarter in the previous year. The impressive growth in EBITDA is as result of operational efficiency arising out of several measures including route rationalization and better vendor management.

The performance for the nine months ended 31<sup>st</sup> Mar'11 too recorded an impressive growth of 26% from Rs.4764 mn to Rs. 6015 mn.



The Coast-to-Coast (shipping) division has registered a revenue growth of 5.4% to Rs 264 mn for the third quarter as compared to Rs. 251 mn in the corresponding quarter in the previous year. However EBITDA has decreased marginally because of increase in operational costs.
