Gati Ltd's FY '15 Consolidated Net Profit rises 59% to Rs. 56.6crores Gati e-Connect revenues rises 164%

Hyderabad, April 28, 2015: Gati Ltd. (NSE: GATI, BSE: 532345) India's leader in Express Distribution and Supply Chain Solutions, declared its financial results for the financial year ending March 2015. Gati's consolidated total income rose by 14% to Rs. 1662.7crores (12 month), while consolidated net profit for the same period was up 59% to Rs. 56.6 crores.

When compared with financial year ended Mar '14 (9 months), the consolidated income shows a growth of 49% from Rs. 1116.6 crores (9 months) to 1662.7 crores (12 months) and registered a growth of 100% in net profit for from Rs. 28.3 crores (9 months) to 56.6 crores (12 months).

Business Highlights:

1) Gati Ltd

In FY '15, revenue from Gati e-Connect, the e-Commerce Logistics services for e-Tailing companies, registered a total income of Rs. 127.4 crores (12 months) with a 164% increase in revenue, compared to Rs. 48.3crores (12 months) in FY'14.

Gati has invested in the last mile delivery capacity over the last year and is now



serviced by a dedicated last mile fleet of 1,350 vehicles (2 wheelers, 3 wheelers and 4 wheelers), serving over 20,000 Pin codes.

2) Gati Kintetsu Express Private Ltd (GKEPL) - Express Distribution and Supply Chain Solutions

For the financial year ended March '15, the total income for GKEPL rose by 12% from Rs. 1023.37 crores (12 months) in FY '14 to Rs. 1142.43 crores (12 months) in FY '15. In the same period, EBITDA has shown an increase from Rs 107.37 crores (12 months) in FY '14 to Rs. 115.98 crores (12 months) in FY '15.

This year GKEPL forayed into the e Fulfilment (eFC) business segment. GKEPL has commissioned e-FC facilities across five major cities in India with daily processing capacity of 30,000 shipments; and is expecting to expand to a capacity of 75,000 shipments by the end of this year. The company aims at scaling up e-FCs in other major cities as well.

Commenting on the company's performance, **Mr. Mahendra Agarwal, Founder and CEO,** Gati Limited said, "The burgeoning e-Commerce sector has given us multiple opportunities and avenues to expand, grow with continued commitment towards technology and operational excellence.
