3i Infotech Reported FY25 Revenue of ₹ 725.8 crore

- **Back to profitability with ₹25.3 crore PAT in FY25**
- **Q4FY24 Revenue at ₹187.0 crore with EBITDA Margin of 8.6%**
- **16 new client wins in Q4 FY25**

Mumbai, May 14th, 2025: 3i Infotech Limited (BSE: 532628) (NSE: 3IINFOLTD), a leading provider of digital transformation, technology services and technology solutions, announced its consolidated financial results for the fourth quarter and full year FY25, ended on March 31st, 2025. The company maintained its growth momentum, displaying consistent progress for the 3rd consecutive quarter.

In Q4 FY25, 3i Infotech reported revenue of ₹187.0 crore, reflecting steady performance compared to ₹181.4 crore in Q3 FY25 and ₹197.0 crore in Q4 FY24. The company delivered strong profitability improvements, with gross margin growing by 14.8% QoQ and 17.4% YoY. Continuing its upward trajectory, operating EBITDA rose to ₹16.0 crore from ₹11.7 crore in Q3 FY25, marking a significant turnaround from a loss of ₹38.8 crore in Q4 FY24. In the quarter, our EBITDA margin also improved to 8.6%, up from 6.4% in the previous quarter.

In terms of geographical footprint, the U.S. remained 3i Infotech's largest market, accounting for 46% of total revenue, with India following closely at 43% of total revenue. Revenue in the U.S. grew by 16.4% QoQ, while India saw a 2.7% QoQ increase.

Application-Automation-Analytics (AAA) continued to be the largest contributor, generating revenue of ₹131.0 crore in Q4FY25, followed by Infrastructure Services (IS) with ₹36.1 crore in Q4FY25.

In Q4 FY25, the Information Technology (IT) sector was a key revenue driver with 37.5% contribution; in FY25, BFSI contributed highest revenue with 40.8% to top line.

In FY25, **3i Infotech strengthened its client portfolio by onboarding over 50 new clients**, including **16 new client wins in Q4 FY25**, reflecting continued market confidence and business expansion.

Commenting on the Q4 FY25 performance, Mr. Raj Ahuja, Acting CEO, 3i Infotech Limited, said:

*"We are pleased to close FY25 on a strong note, maintaining the growth momentum built over the past three quarters. The US continues to be our largest revenue contributor, accounting for little less than half of our business and will continue to be a focus geography while strengthening our footprint in all other geographies. We are further expanding our presence through deeper client engagements and partnerships, with a strong focus on **Cloud, Cybersecurity, Blockchain, AI, and IoT solutions** across our service portfolio, catering to the evolving needs of global enterprises. As we move into FY26, we are confident of building on this momentum, driving sustainable growth, and enhancing value for all our stakeholders."*

Key Highlights of the Consolidated Financial Performance

- PAT recorded at ₹26.9 crore (vs. ₹17.3 crore in Q3 FY25, vs. loss of ₹99.9 crore in Q4 FY24)

- Operating Revenue stood at ₹725.8 crore
- Gross margin ₹83.3 crore in FY25 vs. ₹89 crore in FY24
