DMR Business Performance Update - FY25-26 H1

Faridabad, India – October 31st, 2025 – DMR, a leading engineering consulting company in the field of water, energy and infrastructure, announced today its financial results for H1 of FY25-26, ending in September 30th 2025.

Key Financial Metrics: H1 FY25-26 (April 2025 – September 2025)

Standalone Basis

- Revenue increased by 22.60% year-over-year to ₹566.80 lakhs
- Profit after tax increased by 79.20% year-over-year to ₹133.59 lakhs. Profit after tax margin at 23.57%
- Earnings per share is at ₹1.29, increasing by 79.17% year-over-year

Consolidated Basis

- Revenue increased by 67.19% year-over-year to ₹772.93 lakhs
- Profit after tax increased by 124.42% year-over-year to ₹181.04 lakhs
- Earnings per share is at 1.75, increasing by 124.36% year-over-year
