Twamev Construction and Infrastructure Ltd. Continues the Momentum

Twamev Construction and Infrastructure Ltd. (formerly Tantia Constructions Ltd.) has begun FY26 on a strong note, building on the momentum established in the previous year. For the quarter ended 30th June 2025, the Company delivered robust growth in revenue from operations and a healthy increase in earnings per share (EPS), reflecting continued progress in operational efficiency and disciplined execution. These results underscore the effectiveness of Twamev's transformation strategy and reaffirm its commitment to sustainable, long-term value creation as it advances confidently along its growth trajectory.

Financial Highlights (Standalone) – Quarter Ended 30th June 2025

- Revenue Growth:** Net sales increased by **52% quarter-on-quarter**, reaching **₹11.74 crores** in June 2025, compared to ₹7.72 crores in June 2024.
- Operating EBITDA (before Other Income):** Rebalancing of the project delivery model starting to deliver results with Operating EBITDA margin for the quarter stabilizing at **8.1%**
- Net Profit:** Profit After Tax (PAT) came in at **₹1.34 crore**, supported by strong operations, other income and a favorable tax position.
- Strong EPS Growth:** EPS for the quarter ended 30th June 2025 registered a sharp growth of **27.6%** compared to the corresponding quarter in the previous year.
- Key Project Update:** Billing has commenced under the Shillong Ropeway Project
- Cost Pressures:** Despite key construction inputs inflation remaining benign, cost pressure on margin remains.
- Other Income:** Other Income of **₹0.91 crores** substantially driven by reversal of provisions made from operational income in previous years.
