Virtuoso Optoelectronics Ltd (VOEPL) Shines with Strong Yearly Performance with YoY Revenue growth of 69%, Eyes Promising Growth in FY24 and FY25

30th May 2023, Nashik: <u>Virtuoso Optoelectronics Ltd</u> (VOEPL), an emerging manufacturer of high-volume, large-scale production of Electronics Manufacturing Services (EMS) and consumer & industrial products, announced its financial results for the half year that ended in March 2023.

Performance highlights for half year & full year end March 2023:

- The company has added 2 new manufacturing units in Nashik in FY 22-23 for
 - 1. Manufacturing of Outdoor Units (ODU) for Air Conditioners for capacity of 250,000 units p.a.
 - 2. Manufacturing of Cross Flow Fans (CFFs) which are used in Indoor Unit (IDU) of Split Air Conditioners for a capacity of up to 400,000 units.
- On 3rd March 2023, the company raised Rs 35 crores from marquee investor Mr Ashish Kacholia and others, for growth capital.
- The company will be acquiring 51% in YLP Solutions for a sum of Rs 3.10 Lakhs. Group company will be acquired in line with VOEPL's commitment for transparency and streamlining its business.

Commenting on the performance, Mr. Sukrit Bharati, MD, Virtuoso Optoelectronics Ltd, said

"The company has delivered on strong revenue growth of nearly 69% year on year led by growth in volumes from existing businesses (EMS + IDU) as well as from new products added during the year (IDU) and we are hoping to continue on this growth trajectory in FY24 and FY25 led by further expansion in our manufacturing capacities, which is led by strong demand for our products from key customers. The company has successfully added Outdoor Units to its portfolio and has also become significantly stronger in backward integration. We are looking to grow at 35-40% CAGR for the next 3 years on the revenue front led by volume growth and higher utilisations.

As part of its commitment towards transparency and streamlining activities, VOEPL will be acquiring a majority stake in YLP, a group company with annual project & online trading sales of Rs 72 Lakhs in FY 22-23. This acquisition will allow VOEPL to establish YLP as a subsidiary at a nominal cost of approx. Rs. 3.10 lakhs.
