## RPG Life Sciences Q3 Profit Before Tax grows by 43.6%

Mumbai, 31 January, 2020: RPG Life Sciences Limited has announced its financial results for the quarter ended December 31<sup>st</sup>, 2019.

RPG Life Sciences, engaged in the manufacturing and marketing of pharmaceutical products, posted its Q3 and Nine months results. Q3 revenue is higher than the corresponding quarter last year and PBT has registered a significant jump from Rs 7.25 crores to Rs 10.41 crores. Overall, during nine months, Company's PBT stood at Rs 33.31 crores versus Rs 12.93 crores over similar period last year and revenue increased by 10%.

"Q3 results are consistent with those of Q1 and Q2 both on revenue and profit fronts. The turn-around performance is largely driven by the biggest contributing Domestic business, which grew over 23%. Focus has been on prescription generation, product portfolio rejuvenation, sales force effectiveness enhancement with strict vigil on Sales hygiene." said Mr. Yugal Sikri, Managing Director, RPG Life Sciences Ltd.
