
Record Highest Sales Volume in Q3FY23 +40%, Record Highest PAT in Q3FY23 +28%, Revenue in Q3FY23 +29%,


Key Consolidated Financial and Operational Highlights for Q3FY23:

- ➤ Revenue from operations was up 29% to Rs.569.29 Crore as compared to Rs. 440.02Crore in Q3FY22;
- Total sales volumes increased by 40% to 91,232 tonnes as compared to 65,088 tonnes in Q3FY22;
- > PAT increased by 28% to Rs.13.02 Cr. as compared to Rs.10.17 Cr. in Q3FY22;
- ➤ EBIDTA increased by 12% to Rs.28.07 Crore in Q3FY23 as compared to Rs.25.09 Crore in Q3FY22;
- ➤ EBIDTA/ton at Rs.3076 in Q3FY23 vs. Rs.3853 in Q3FY22; declined by 20% YoY; However, the EBIDTA/ton on QoQ basis grew by 11.5% from Rs.2760 in Q2FY23

This would help significantly in savings power cost which is a significant cost element in our manufacturing process. Moreover, there will be reduction in the carbon footprint by reducing the emission of carbon dioxide into the atmosphere. This is an Important step towards having a renewable and alternate source of energy to the company.

"During this Quarter the Company has register a healthy set of numbers in terms of Revenue, Highest Sales Volume and Profitability, this is mainly due to better capacity utilization, improved sales realizations and increase in share of Value added Products. The Commercial production of our new Color Coating Line has commenced in this month we are happy that this high margin value added product will further help in strengthening the Company's margin on blended Level in medium to long term.

In lines with our commitment to environment and making ourselves energy self-sufficient, I am happy to announce that now the maximum of power requirements in our Sikendrabad, U.P. plant now shall be fulfilled by the renewable resources.
