INDEPENDENT AUDITOR'S REVIEW REPORT ON REVIEW OF INTERIM CONSOLIDATED FINANCIAL RESULTS

TO THE BOARD OF DIRECTORS OF JSW Energy Limited

- 1. We have reviewed the accompanying Statement of Consolidated Unaudited Financial Results of JSW Energy Limited ("the Parent") and its subsidiaries (the Parent and its subsidiaries together referred to as "the Group"), and its share of the net profit after tax and total comprehensive income of its associate and a joint venture for the quarter and six months ended September 30, 2025 ("the Statement") being submitted by the Parent pursuant to the requirement of Regulation 33 and Regulation 52 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("the Listing Regulations").
- 2. This Statement, which is the responsibility of the Parent's Management and approved by the Parent's Board of Directors, has been prepared in accordance with the recognition and measurement principles laid down in the Indian Accounting Standard 34 "Interim Financial Reporting" ("Ind AS 34"), prescribed under Section 133 of the Companies Act, 2013 read with relevant rules issued thereunder and other accounting principles generally accepted in India and in compliance with Regulation 33 and Regulation 52 of the Listing Regulations. Our responsibility is to express a conclusion on the Statement based on our review.
- 3. We conducted our review of the Statement in accordance with the Standard on Review Engagements (SRE) 2410 "Review of Interim Financial Information Performed by the Independent Auditor of the Entity", issued by the Institute of Chartered Accountants of India (ICAI). A review of interim financial information consists of making inquiries, primarily of Parent's personnel responsible for financial and accounting matters, and applying analytical and other review procedures. A review is substantially less in scope than an audit conducted in accordance with Standards on Auditing specified under Section 143(10) of the Companies Act, 2013 and consequently does not enable us to obtain assurance that we would become aware of all significant matters that might be identified in an audit. Accordingly, we do not express an audit opinion.

We also performed procedures in accordance with the circular issued by the SEBI under Regulation 33(8) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended, to the extent applicable.

- 4. The Statement includes the results of the entities included in Appendix A.
- 5. Based on our review conducted and procedures performed as stated in paragraph 3 above and based on the consideration of the review reports of the other auditors referred to in paragraph 6 below, nothing has come to our attention that causes us to believe that the accompanying Statement, prepared in accordance with the recognition and measurement principles laid down in the aforesaid Indian Accounting Standard and other accounting principles generally accepted in India, has not disclosed the information required to be disclosed in terms of Regulation 33 and Regulation 52 of the SEBI (Listing

Obligations and Disclosure Requirements) Regulations, 2015, as amended, including the manner in which it is to be disclosed, or that it contains any material misstatement.

We did not review the interim financial information of 102 subsidiaries included in the consolidated unaudited financial results, whose interim financial information reflect total assets of Rs. 46,065.91 crores as at September 30, 2025 and, total revenues of Rs. 1,783.93 crores and Rs. 3,278.81 crores for the quarter and six months ended September 30, 2025, respectively, total net profit after tax of Rs. 438.06 crores and Rs. 652.69 crores for the guarter and six months ended September 30, 2025, respectively and total comprehensive income of Rs. 594.08 crores and Rs. 697.74 crores for the quarter and six months ended September 30, 2025, respectively and net cash outflows of Rs. 587.77 crores for the six months ended September 30, 2025, as considered in the Statement. These interim financial information have been reviewed by other auditors whose reports have been furnished to us by the Management and our conclusion on the Statement, in so far as it relates to the amounts and disclosures included in respect of these subsidiaries, is based solely on the reports of the other auditors and the procedures performed by us as stated in paragraph 3 above.

Our conclusion on the Statement is not modified in respect of the above matter with respect to our reliance on the work done and the reports of the other auditors.

7. The consolidated unaudited financial results includes the interim financial information of 24 subsidiaries which have not been reviewed by their auditors, whose interim financial information reflect total assets of Rs. 203.89 crores as at September 30, 2025 and, total revenue of Rs. 4.24 crores and Rs. 17.24 crores for the guarter and six months ended September 30, 2025 respectively, total loss after tax of Rs. 19.02 crores and Rs. 18.51 crores for the quarter and six months ended September 30, 2025, respectively and total comprehensive loss of Rs. 5.32 crores and Rs. 1.8 crores for the quarter and six months ended September 30, 2025, respectively and net cash outflows (net) of Rs. 22.81 crores for the six months ended September 30, 2025, as considered in the Statement. The consolidated unaudited financial results also includes the Group's share of profit after tax of Rs. 1.96 crores and Rs. 4.95 crores for the quarter and six months ended September 30, 2025 respectively and total comprehensive income of Rs. 1.96 crores and Rs. 4.95 crores for the quarter and six months ended September 30, 2025 respectively, as considered in the Statement, in respect of an associate and a joint venture, based on their interim financial information which have not been reviewed by their auditors. According to the information and explanations given to us by the Management, these interim financial information are not material to the Group.

Our Conclusion on the Statement is not modified in respect of our reliance on the interim financial information certified by the Management.

- 2 JSW Neo Energy Limited, ("JSWNEL") a wholly owned subsidiary of the Company has completed the acquisition of O2 Power Midco Holdings Pte. Limited and O2 Energy SG Pte. Limited and their subsidiaries (O2 Entities) having a consolidated operational and under construction / development renewable energy portfolio of 4.7 GW from O2 Power Pooling Pte. Limited, O2 Power SG Pte. Limited and certain individuals (Sellers) on April 09, 2025. The entities have become subsidiaries of JSWNEL with effect from April 09, 2025.

The Group has accounted for the above acquisitions in accordance with Ind AS 103- Business Combination, wherein purchase consideration has been allocated on a provisional basis pending final determination of fair value of acquired assets and liabilities.

The above subsidiaries contributed revenue from operations of ₹ 309.33 crore and ₹ 553.81 crore and loss after tax of ₹ 32.15 crore and ₹ 46.30 crore during the quarter and six months ended September 30, 2025 respectively.

3 JSW Neo Energy Limited, ("JSWNEL") a wholly owned subsidiary of the Company, has completed the acquisition of 3 special purpose vehicles ("3 SPVs") collectively holding a portfolio of 125 MW of wind generation capacity from Hetero Labs Limited and Hetero Drugs Limited ("Hetero Group") on January 10, 2025.

The Group has accounted for the above acquisitions in accordance with Ind AS 103- Business Combination, wherein purchase consideration has been allocated on a provisional basis pending final determination of fair value of acquired assets and liabilities.

The above subsidiaries contributed revenue from operations of ₹ 52.42 crore and ₹ 88.11 crore and profit after tax of ₹ 24.57 crore and ₹ 33.49 crore during the quarter and six months ended September 30, 2025 respectively.

4 The Company has completed the acquisition of KSK Mahanadi Power Company Limited ("KMPCL") on March 06, 2025 pursuant to National Company Law Tribunal ("NCLT") approval order dated Februrary 13, 2025, Accordingly, the Company holds 74% equity shares of KSK Mahanadi Power Company Limited and the secured Financial Creditors ("FC") collectively hold the balance 26%, as per the terms of the Resolution Plan, wherein the FC have a put option and the Company has a call option for the 26% stake held by FC, excercisable from end of first year from acquisition date of KMPCL till end of 5 years.

The Group has accounted for the above acquisitions in accordance with Ind AS 103- Business Combination, wherein purchase consideration has been allocated on a provisional basis pending final determination of fair value of acquired assets and liabilities.

The above subsidiary contributed revenue from operations of ₹ 1,545.79 crore and ₹ 3,103.08 crore and profit after tax of ₹ 170.52 crore and ₹ 391.12 crore during the quarter and six months ended September 30, 2025 respectively.

5 JSW Hydro Energy Limited ("JSWHEL") a stepdown subsidiary of the Company having its Karcham Wangtoo power plant in the state of Himachal Pradesh was obligated to supply 12% free power to the Home State (Government of Himachal Pradesh "GoHP") for the initial 12 years and 18% free power for the subsequent 28 years as per the Implementation Agreement ("IA"). However, the Central Electricity Regulatory Commission ("CERC") order dated March 17, 2022, capped the free power at 12% (excluding 1% for Local Area Development Authority (LADA)).

Based on the aforesaid CERC order, JSWHEL filed a writ petition with the Hon'ble High Court of Himachal Pradesh seeking alignment of the IA with the CERC order dated March 17, 2022. The High Court gave its judgement dated May 28, 2024 directing GoHP to align the IA with CERC order.

Aggrieved by the judgment of the High Court, GoHP filed an appeal with Hon'ble Supreme Court. Hon'ble Supreme Court vide its judgement dated July 16, 2025, allowed the appeal filed by the GoHP and set aside the judgement of High Court and directed JSWHEL to supply 18% free power from September 14, 2023 onwards. Pursuant to the order and judgement of the Supreme Court, the Company has started supplying free power of 18% from July 19, 2025 to GoHP. Further, the Company is in discussion with the GoHP on the modalities of supplying additional free power of 6% to GoHP for the earlier period from September 14, 2023 to July 18, 2025 from the available untied capacity.

6 JSW Neo Energy Limited ("JSWNEL"), wholly owned subsidiary of JSW Energy Limited ("Company") has completed the acquisition of O2 Power Midco Holdings Pte Limited ("O2 Power") and O2 Energy SG Pte. Limited ("O2 Energy") and their subsidiaries ("O2 Entities") as on April 09, 2025.

Prior to acquisition of O2 Entities by JSWNEL, by a Share Purchase Agreement dated March 14, 2024 and the Amendment Agreement dated September 02, 2024 ("SPA"), O2 Power SG Pte. Ltd. and Clean Solar Power (Bhainsada) ("O2 Entity") Private Limited had agreed to sell 100% shareholding in Beempow Energy Private Limited ("BEEMPOW") ("O2 Entity") to EPIC Green Urja Private Limited and Schemes of Infrastructure Yield Trust ("BEEMPOW Buyers") and had transferred 49% of the shareholding in BEEMPOW Buyers.

Pursuant to the SPA, the balance 51% in BEEMPOW was transferred on June 06, 2025, to BEEMPOW Buyers and BEEMPOW has ceased to be a step-down subsidiary of JSWNEL and the Company with effect from June 06, 2025.

7 KWIPL owns and operates a dedicated water intake and transportation infrastructure that supplies raw water to the KMPCL. JSWEL had submitted a Settlement Plan for the settlement of debt of KWIPL which was approved by the Committee of Creditors (CoC) and accordingly, the CoC had approved the withdrawal of the insolvency resolution process of KWIPL. The National Company Law Tribunal, Hyderabad (NCLT) also allowed the withdrawal of the application for CIRP for KWIPL. JSWEL had implemented the Settlement Plan and as a part of the Settlement Plan, acquired majority shareholding of KWIPL on August 04, 2025.

As part of the Settlement Plan, the Company has paid the settlement amount of ₹ 962 Crores to the Lenders of KWIPL. Post-acquisition, KWIPL has become a subsidiary of the Group. The accounting for the aforesaid transaction has been done as an asset acquisition.

- 8 The Kutehr Hydroelectric Power Plant, situated in Chamba district of Himachal Pradesh having 3 units of 80MW each (240MW) were commissioned on August 02,2025 August 06, 2025 and August 08,2025 respectively marking the full commissioning of the plant.
- 9 JSW Neo Energy Limited (JSWNEL), a wholly-owned subsidiary of the Company, has signed a definitive agreement with Statkraft IH Holding AS to acquire 100% equity shares of Tidong Power Generation Private Limited (TPGPL) having a 150 MW under construction hydro power project. The transaction is subject to receipt of the necessary regulatory approvals and other customary conditions under the definitive agreement. Upon consummation of the transaction, TPGPL will become a subsidiary of JSWNEL and step-down subsidiary of the Company.
- 10 The consolidated results have been reviewed by the Audit Committee and approved by the Board of Directors at their respective meetings held on October 17, 2025. The Statutory Auditors of the Company have carried out a limited review of the results for the quarter and six months ended September 30, 2025.

- 1. - 2. - The Company has completed the acquisition of KSK Mahanadi Power Company Limited ("KMPCL") on March 06, 2025 pursuant to National Company Law Tribunal ("NCLT") approval order dated Februrary 13, 2025. Accordingly, the Company holds 74% equity shares of KSK Mahanadi Power Company Limited and the secured financial creditors ("FC") collectively hold the balance 26%, as per the terms of the Resolution Plan, wherein the FC have a put option and the Company has a call option for the 26% stake held by FC, excercisable from end of first year from acquisition date of KMPCL till end of 5 years.
- 3 KWIPL owns and operates a dedicated water intake and transportation infrastructure that supplies raw water to the KMPCL. JSWEL had submitted a Settlement Plan for the settlement of debt of KWIPL which was approved by the Committee of Creditors (CoC) and accordingly, the CoC had approved the withdrawal of the insolvency resolution process of KWIPL. The National Company Law Tribunal, Hyderabad (NCLT) also allowed the withdrawal of the application for CIRP for KWIPL. JSWEL had implemented the Settlement Plan and as a part of the Settlement Plan, acquired majority shareholding of KWIPL on August U4, 2U25.
 - As part of the Settlement Plan, the Company has paid the settlement amount of ₹ 962 Crores to the Lenders of KWIPL. Post-acquisition, KWIPL has become a subsidiary of the company.

Mumbai, India: JSW Energy Limited ("JSW Energy" or the "Company") today reported robust operational and financial performance for the quarter ("Q2 FY26" or the "Quarter") ended September 30, 2025.

Mr. Sharad Mahendra, Joint Managing Director and CEO of JSW Energy:

"We are pleased to report a strong quarterly performance, with earnings growth primarily driven by healthy organic capacity additions and the recently completed inorganic capacities of Mahanadi and O2 Power. This quarter has been especially exciting, as we commissioned the 240 MW Kutehr Hydroelectric Project in record time and completed our very first floating solar project — a true testament to our execution excellence and commitment to innovation. The integration of O2 Power and Mahanadi is progressing smoothly, and we are already witnessing meaningful synergies taking shape across our operations. We continue to remain steadfast in our focus on achieving our ambitious targets — 30 GW of generation capacity and 40 GWh of storage by 2030."

Q2 FY26 Consolidated Operational & Financial Performance

- Installed capacity increased by 5.5 GW (up 71% YoY), leading to 52% YoY generation increase
- Q2 FY26 EBITDA grew by robust 67% YoY to ₹ 3,180 Crore; H1 FY26 EBITDA grew by 79% YoY to ₹ 6,237 Cr

- Signed definitive agreement with Statkraft IH Holding to acquire the 150 MW underconstruction Tidong HEP, for an Enterprise Valuation of ~₹1,728 crores, subject to closing adjustments.
- Integration of recently acquired Mahanadi plant and O2 Power progressing well;
 Mahanadi 1,800 MW operational capacity generated 2.8 BUs during Q2 FY26, resulting in an EBITDA of ₹807 Cr.

Operational Capacity

Installed capacity increased by 443 MW during the quarter to 13.2 GW, driven by 240 MW Kutehr HEP, and 203 MW of organic renewable capacity addition. The current total locked-in generation capacity stands at 30.5 GW.

Generation

During the quarter, Net Generation at 14,938 MUs increased by 52% YoY, while generation under long-term PPA at 13,415 MUs increased by 56% YoY, both driven by organic RE capacity additions, contribution from the Mahanadi Plant and O2 Power, and higher generation at Vijayanagar post long-term tie-up. Short-term thermal sales at 1,441 MUs were up 44% YoY with the shift towards domestic coal-based capacity (Utkal and Mahanadi).

Energy Products and Services

- During the quarter, the Company signed Battery Energy Storage Purchase Agreements of 680 MWh capacity. Current total locked in storage capacity stands at 29.4 GWh with storage agreement signed for 25.2 GWh storage capacity.
- Trial runs underway for the 3,800 TPA green hydrogen project situated at Vijayanagar, with commissioning expected soon.
- Equipment have been sourced for our 5GWh battery assembly plant in Pune; line set up and commissioning is expected in Q3FY26.

Consolidated Financial Performance

- During the quarter, Total Revenue increased by 55% YoY to ₹5,361 Crore from ₹3,459 Crore resulting into EBITDA growth of 67% YoY from ₹1,907 Crore to ₹3,180 Crore, driven by organic capacity additions and contribution from Mahanadi and O2 Power.
- Strategic acquisitions boosting EBITDA growth as Mahanadi plant contributed incremental ₹807 Crore while O2 Power contributed ₹267 Crore of EBITDA during the quarter.
- Finance costs during the quarter increased to ₹ 1,418 Crore vis-à-vis ₹ 518 Crore in Q2 FY26
 due to incremental borrowings for funding the ongoing capacity expansion. Weighted
 average cost of debt marginally declined to 8.79%.
- Profit after tax decreased 17% YoY from ₹ 853 Crore in Q2 FY25 to ₹ 705 Crore in Q2 FY26 due to capitalisation of new projects, while Cash PAT grew by 27% from ₹ 1,190 Crore in Q2 FY25 to ₹ 1,512 Crore in Q2 FY26.

Balance Sheet

The Consolidated Net Worth and Net Debt as on Sep 30, 2025 were ₹ 29,124 Crore and ₹ 61,960 Crore respectively, resulting in a Net Debt to Equity ratio of 2.1x. Net Debt to Proforma Steady-state EBITDA ¹ (excl. CWIP) stood at 4.8x. Receivables in DSO terms are at a healthy level of 64 days in the quarter.

Cash and Cash Equivalent

Liquidity remains ample with sizeable Cash balances² of ₹6,181 Crores as of Sep 30, 2025.
