## Arkade Developers revenue rises to ₹ 165 Cr in Q1 FY26

- Revenue for Q1 FY26 grew 31.6% to ₹ 165 Cr; PBT stood at ₹ 38 Cr; while net profit was at ₹ 29 Cr
- PBT Margin for Q1 FY26 was 23.1%; PAT margin was 17.4%
- Q1 FY26 pre-sales grew 17.1% to ₹ 142 Cr; collections rose 41.8% to ₹ 170 Cr
- The Board has recommended a maiden interim Dividend of 10%
- Promoter Mr. Amit M Jain and Whole Time Directors, Mr Sandeep Jain and Mr Arpit Jain are forgoing Dividend to enhance Shareholder Value

**Mumbai, July 25<sup>th</sup>, 2025:** Arkade Developers Limited, amongst the leading real estate development companies in Mumbai, reported revenue growth of 31.6% year-on-year at ₹ 165 Cr for the quarter ended June 30, 2025. Profit Before Tax stands at 38 Cr, while Net profit for the quarter was ₹ 29 Cr. The strong revenue growth for the quarter came from robust growth of pre-sales achieved over the last few quarters, the revenue recognition of which was done in Q1 FY26.
