Krystal Reports Strong Q1 FY26 Performance

Revenue Grows 25.6% YoY & EBITDA Rises 31.4% YoY

Driven by Strategic Contract Wins and Expansion Across Key Verticals

Mumbai, July 31st, 2025: Krystal Integrated Services Limited (KISL), a well-diversified service provider in integrated facility management services, Staffing solutions, Security services, Catering and Waste management across India, is pleased to announce its unaudited financial results for the first quarter ended June 30th, 2025.

Q1 FY26 Highlights:

- Revenue from operations increased 25.6% YoY to Rs. 323.08 Crore in Q1 FY26 compared to Rs. 257.15 Crore in Q1 FY25 on account of new order wins across verticals.
- EBITDA grew by 31.4% to Rs. 21.35 Crore in Q1 FY26 compared to Rs. 16.25 Crore in Q1 FY25
- EBITDA Margin improved marginally to 6.61% in Q1 FY26 as against 6.32% in Q1 FY25 due to lower admin costs and improved cost efficiency.
- PAT grew by 7.4% to Rs. 16.33 Crore in Q1 FY26 compared to Rs. 15.20 Crore in Q1 FY25.
- PAT margin stood at 5.06% for Q1 FY26 as compared to 5.91% in Q1 FY25. This slight decline is due to the conservative approach to taxation, aimed at reducing volatility in the PAT margin throughout the year.

Commenting on the performance, Mr. Sanjay Dighe, CEO & Whole Time Director, Krystal Integrated Services Ltd, said,

"We have commenced FY26 on a promising note, with Q1 performance reinforcing our growth trajectory and our focus on strategic expansion. Our efforts to evolve as a comprehensive solutions provider are bearing fruit, as we continue to build scale across verticals and strengthen our presence in both core and emerging service areas.

The first quarter of the fiscal year was marked by significant momentum in our facility management segment. We

secured several prestigious contracts during the period, which underscore our growing reputation for delivering integrated, high-quality services across complex public infrastructure assets. We were awarded a three-year contract worth Rs. 31.55 crore by Maha Mumbai Metro Operation Corporation Ltd. to provide attendant manpower services across multiple metro lines in Mumbai. This win highlights our expanding role in supporting the day-to-day operations of city-wide transport systems.

We also secured a contract worth Rs. 20.26 crore from the Airports Authority of India to manage facility services at the newly developed terminal of the Patna airport. This is a significant addition to our airport portfolio and shows growing confidence in our ability to manage busy and important public spaces. Another notable win this quarter was a Rs. 12.83 crore housekeeping contract from MMMOCL, which includes the cleaning and upkeep of trains, depots, and key infrastructure along Metro Lines 2A and 7. These wins reflect the increasing scale of work we are handling while maintaining the profitability, and the trust that clients continue to place in us.

In line with our earlier focus on expanding into new service lines, in Q1 FY26, we have begun booking revenues from the water treatment project, marking a key step towards securing larger opportunities in these sectors going forward. Additionally, revenue from corporate clients saw significant growth on standalone basis, increasing to ₹55.66 crore in Q1 FY26 from ₹18.21 crore in Q1 FY25, reflecting our strengthening presence in this segment.

With this strong start to the year, we are optimistic about the road ahead. We remain focused on improving the quality of our services, entering new segments, and maintaining the strong relationships we have built over the years. I thank the entire Krystal team for their hard work and our clients and partners for their continued support and belief in our journey."
