REVENUE FROM OPERATIONS AT ₹9,481.44 LAKH; PAT AT ₹773.55 LAKH; PAT MARGIN IMPROVES TO 8.16% FROM 7.15% LAST YEAR

Delhi NCR, November 7, 2025: Mach Conferences and Events Limited (BSE: MCEL), one of India's leading MICE (Meetings, Incentives, Conferences and Exhibitions) companies, announced its financial results for the half year ended September 30, 2025.

The Company reported a standalone revenue from operations of ₹9,481.44 lakh, with a Profit Before Tax (PBT) of ₹1,010.17 lakh and a Profit After Tax (PAT) of ₹773.55 lakh for H1 FY2025-26. The performance is noteworthy considering that the impact of the India–Pakistan conflict, which persisted for nearly two months, brought all travel activities to a standstill.

Despite these challenges, Mach Conferences and Events Limited delivered resilient results, achieving a PAT margin of 8.16%, representing an improvement of approximately 14% over 7.15% recorded in H1 FY2024-25. This reflects the Company's strong fundamentals, operational discipline, and efficient cost management.
