### **KIOCL ACHIEVES STELLAR PERFORMANCE IN Q1**

KIOCL Limited, a CPSU under Ministry of Steel, reported 139% increase in Revenue from Operations at Rs. 1042.05 crores and a Profit Before Tax (PBT) of Rs.295.22 crores & Profit After Tax (PAT) of Rs.215.92 crores for the 1st quarter of FY 2021-22.

Board of Directors of the Company, approved the Un-audited Financial Results for the first quarter ended on 30th June 2021, in its meeting, held on 05.08.2021 through Video Conference.

Company reported, 18% higher Pellet Production at 6.03 Lakh Tons, compared to 5.11 Lakh tons in 1<sup>st</sup> Quarter of the previous year.

### **Highlights of the Performance:**

- Total Revenue earned is Rs. 1059.50 crores as against Rs. 460.58 crores, up by 130%
- Profit before Tax Rs. 295.22 crores as against Rs.18.97 crores, up by 1456 %

Shri Swapan Kumar Gorai, CMD cum Director (Finance), KIOCL Ltd., stated that despite prolonged lockdown due to second wave of COVID-19 during the quarter Apr - June 2021, the Company was able to maintain its normal operation by reorganizing its resources effectively in achieving consistent growth. The Pellet Plant Operations & Mineral Exploration Activities continued at its optimum level after enforcing strict preventive measures against COVID-19 pandemic.

He also stated that the high profitability was due to sustained high price realization of its pellet in export market.
