Aster DM Healthcare Q3FY2019 EBITDA rose 54 % to Rs. 263 crore

Q3FY19 Revenue up 19% at Rs 2,150 crore Strong growth delivered during the quarter with new hospitals in pipeline

Kochi, February 13, 2019: Aster DM Healthcare, one of the largest private healthcare service providers in multiple GCC states and an emerging healthcare player in India, today announced its financial results for the quarter & nine months ended December 31, 2018.

Revenue from operations for Q3FY19 was up by 19% to Rs. 2,150 crore as against Rs 1,814 crore in Q3FY18. EBITDA was up by 54% to Rs. 263 crore from Rs. 172 crore in Q3 FY18. PAT adjusted for the exceptional income in previous year grew by 42% from Rs. 71 crore in Q3FY18 to Rs. 100 crore in current quarter.

The Company's strong growth is a reflection of its focus on quality healthcare, the strength of its diversified healthcare offerings and a strong thrust on enhancing efficiencies.

Financial Performance Highlights

Performance Review for Q3FY19 vs. Q3FY18

- Revenue from operations improves by 19% to Rs. 2,150 crore compared to Rs. 1,814 crore
- EBITDA (excluding other income) increases by 54% Y-o-Y to Rs. 263 crore compared to Rs. 172 crore
- PAT (adjusted for exceptional income in previous year) increases to Rs. 100 crore compared to Rs. 71 crore

Performance Review for 9MFY19 vs. 9MFY18

- Revenue from operations improves by 17% to Rs. 5,762 crore compared to Rs. 4,937 crore
- EBITDA (excluding other income) grew by 47% Y-o-Y to Rs. 513 crore compared to Rs. 350 crore
- PAT (adjusted for exceptional income in previous year) increases to Rs. 125 crore compared to loss of Rs. 6 crore



Commenting on the performance for Q3 & 9MFY19, Dr. Azad Moopen, Chairman, Aster DM Healthcare, said:

"We are happy with our performance growth in a quarter wherein seasonality plays to our advantage. We have done well both sequentially and on a corresponding quarter basis.

Our business in India is growing well and we are making progress here. Our expansion in our brand across geographies will definitely help our global foot print. Our strategy here is to work on setting up two hospital every year and gradually increasing the capacity utilization. Over a period of time we also strongly believe that the Ayushman Bharat scheme will give opportunities for some of our businesses in tier 2 cities.

The GCC businesses also holds strong especially with majority of the geographies moving towards mandatory insurance.

With major part of the financial year gone by and our performance positively reflected in our results, we are confident on ending the year on a strong note with a strong focus on clinical excellence and expansion."

Aster DM Healthcare is a 31-year-old integrated and comprehensive healthcare service organization. The Company is one of the few entities across the globe providing the complete circle of care from primary, secondary, tertiary to quaternary medical care. These are manned by its 17,800+ employees from across the world, delivering on a simple yet strong promise to its people: "We'll treat you well."

The Company has the unique distinction of serving people by providing quality healthcare to all segments of the society regardless of their economic or social positioning. In line with this, Dr. Azad Moopen, Founder Chairman and Managing Director at Aster DM Healthcare conceptualized the Company's three brands - Medcare for the high income, Aster for the middle-income and Access for low-income strata of the population. The Company has an asset light business model wherein the land and civil structure of most of its hospitals are leased. It is also optimally positioned in the Medical tourism sector with a large number of GCC residents visiting India to avail quality and cost-effective healthcare.

Seasonality

Seasonality is unique to GCC businesses and skews the picture significantly for the first and second half-financial year results.

There is a decline in volumes across hospitals, pharmacies and segments during the summer months in the GCC countries. Expats form a major proportion of the population in GCC countries barring Saudi Arabia and during the extreme summer season and school holidays, a large amount of population leave the GCC region. Some doctors also travel back to their home country during this period as well. The impact is visible across industries and reflected particularly more in primary care facilities like clinics and pharmacies.



H1 and H2 revenues in GCC are usually split in 45%-55% but the EBITDA split can vary as much as 30% and 70% for H1 and H2. Increase in revenue in H2 results in proportionately larger increase in profitability due to operating leverage. Seasonality variation has consistently been visible over several years and can be expected to continue.

Segmental Performance

Hospitals

Aster DM Healthcare's Hospital network consists of 10 hospitals in GCC states and 11 multi-specialty hospitals in India. Our hospitals in India are located in Kochi, Calicut, Kottakkal, Wayanad, Bengaluru, Kolhapur, Vijayawada, Guntur, Hyderabad & Ongole and are generally operated under the "Aster", "MIMS", "Ramesh" or "Prime" brands.

Revenues increased by 21% to Rs. 2,877 crore in 9MFY19 from Rs. 2,386 crore in 9MFY18. EBITDA (excluding other income) increased by 54% from Rs. 226 crore in 9MFY18 to Rs. 347 crore in 9MFY19. The EBITDA margin was at 12% in 9MFY19 compared to 10% in 9MFY18. This performance was driven by addition of new specialties, services and increase in beds.

Clinics

We are one of the largest and most widespread network of clinics across the Middle East. The Aster DM network has 113 clinics in total with 105 clinics in GCC states and 8 clinics in India.

Clinics have been critical in developing Aster's brand, principally in new locations and geographies. Clinics act as a referral for Aster hospitals. Clinics are also crucial for pharmacies and most pharmacies are integrated with clinics, which ensure higher footfalls and faster breakeven. The asset light nature of clinics along with higher return ratios has helped Aster expand its network of clinics rapidly without impacting its balance sheet.

Revenues for GCC clinics increased by 14% to Rs. 1,454 crore in 9MFY19 from Rs. 1,278 crore in 9MFY18. EBITDA for GCC clinics increased 35% from Rs. 144 crore in 9MFY18 to Rs. 195 crore in 9MFY19. The EBITDA margin was at 13.4% in 9MFY19 compared to 11.3% in 9MFY18. This performance was driven by ramp up in new clinics set up in GCC states in the recent past and increase in footfalls from existing clinics.

Pharmacies

We are the largest pharmacy chain in the GCC with 219 retail stores including 186 in UAE, 7, 12, 6, 6 and 2 in Kuwait, Jordan, Qatar, Oman and Bahrain respectively. An improving product mix combined with exclusive tie ups and strong associations with various pharma companies have all resulted in a healthy profitability profile. Revenues increased by 20% to Rs. 1,553 crore in 9MFY19 from Rs. 1,297 crore in 9MFY18. EBITDA increased 22% from Rs. 106 crore in 9MFY18 to Rs. 129 crore in 9MFY19.



Medical Excellence Highlights

Since inception, Aster DM Healthcare has been in continuous pursuit to push boundaries of excellence in health care and cater to the needs of patients, thereby setting global benchmarks in the field of medicine and patient care. It has accomplished numerous milestones and performed several surgeries that were "firsts". Mentioned below are some of the significant achievements, in the quarter under review, that are a testament to our clinical excellence:

- Aster CMI Hospital has performed Ace Split liver transplant for a 32 month old baby
- Citizen of Iraq weighing 212 kg with BMI of 90 who was previously operated in Germany underwent revision Sleeve and MGB under the Department of Bariatric surgery at Aster CMI hospital
- Aster CMI has performed 4 Robotic surgeries in Urology COE conducted in Dec 2018
- Aster Medcity Women's Health achieved another milestone in the month of November when the 1000th baby was delivered on 20th November 2018
- Aster Medcity organised Aster Nutricon 2018 on 18th November 2018 at Avenue Regent. This CME features on bariatric nutrition including the role of nutrition in bariatric surgery, medical and nutritional management in pre and post-bariatric surgery and nonsurgical management of obesity
- Aster MIMS Calicut performed DBS surgery which is first in North Kerala. 3 surgeries were done till December 2018
- Aster MIMS Calicut performed successful heart surgery for a Somalia patient diagnosed with severe valvular pulmonary stenosis, small hypertrophic right ventricle. He was rejected from other hospitals because of high risks
- Aster Medcity has joined CDC's AMR Challenge- A global commitment to take action against spread of antimicrobial resistance
- For the first time in Dubai, a Single Incision Colorectal Laparoscopic Surgery was performed in Aster Hospital, Al Qusais
- Medcare Orthopedic and Spine Hospital in UAE performed a spinal reconstruction surgery on a 28-year-old Emirati man suffering from Achondroplasia (a form of dwarfism)

Milestones and introductions

- Aster Medcity has launched a separate dedicated area for Physical Medicine and Rehabilitation consisting of 16 beds
- Aster Medicty commenced a CRITICAL CARE PROJECT, a series of session with IMA and local GP's showcasing Aster ED and critical care dept excellence in handling critical cases
- STEMI PROJECT initiated project to divert STEMI cases to Aster Medcity by contacting periphery hospitals within 15KM range from Aster Medcity



- Aster MIMS Calicut entered into a MoU with National Health Mission signed for empanelment of Paediatric Cardiac Surgery. Payments for the same has started as well.
- Ramesh Hospitals Launched "Komali Fertility center" at Guntur, which shall be operational from 1st April, 2019
- Ramesh Hospitals' Main Branch in Vijayawada organized Telemedicon 2018, an international conference with 750 delegates from 1st Nov to 3rd Nov,2018.

Corporate Social Responsibility (CSR) Highlights

- Around 140,271 individuals have been treated through mobile medical services across GCC, India & Philippines region
- Around 145,998 individuals have benefitted from Basic Life Support (BLS) trainings
- 24, 877 free investigations and surgeries were conducted
- 433,883 individuals were treated through 2826 medical camps
- 108 people of determination (differently abled) were appointed across various establishments of Aster DM Healthcare
- 233,488 people have benefitted through the aid programme in Somali Land, Jordan, Bangladesh and Kerala
