Aster DM Healthcare Q4 FY21 revenue up 7% to Rs. 2,391 Crs., EBITDA up 2% to Rs. 336 Crs. and PAT up 14% to Rs. 105 Crs. sequentially over Q3 FY21

Bangalore, **June 22**, **2021**: Aster DM Healthcare, one of the largest private healthcare service providers in multiple GCC states and an emerging healthcare player in India, today announced its financial results for the quarter ended March 31, 2021.

KEY HIGHLIGHTS OF THE QUARTER

- Operational Revenue increased by 7% Q-o-Q to Rs. 2,391 Crs. compared to Rs. 2,228 Crs and increased by 5% Y-o-Y compared to Rs. 2,280 Crs. in FY 20 Q4.
- EBITDA (excluding other income and fair value of put option) increased by 2% Q-o-Q to Rs. 336 Crs. compared to Rs. 328 Crs and reduced by 17 % Y-o-Y compared to Rs. 404 Crs. in FY 20 Q4
- PAT (Pre-Non-Controlling Interest) increased by 9% to Rs. 117 Crs. Q-o-Q compared to Rs. 107 Crs and reduced by 20 % Y-o-Y compared to Rs. 146 Crs. in FY 20 Q4.
- PAT (Post Non-Controlling Interest) increased by 14% to Rs. 105 Crs. Q-o-Q compared to Rs. 92 Crs and reduced by 20% Y-o-Y compared to Rs. 131 Crs. in FY 20 Q4.

Commenting on the performance for Q4 FY21, Dr. Azad Moopen, Founder Chairman and Managing Director, Aster DM Healthcare, said:

"The Q4FY21 saw the second wave of Covid for GCC region. The international borders were closed, travel restrictions, night curfews and lockdowns impacted the Hospitals and Pharmacies business. Restrictions on electives were imposed and at certain locations like Qatar, our workforce was borrowed by State bodies to meet the pandemic needs.

In India, Q4FY21 witnessed first wave of pandemic receding. Our Hospitals saw increased occupancy and patient visits. This is reflected in our revenues and profitability.

We continue to be committed to our expansion in India and see a strong potential for growth. In order to widen our healthcare offerings for our patient base, we are actively expanding Aster Labs and pharmacy distribution network in India. This is in line with the strategy to have wider presence with asset light model.

We started the Aster Whitefield Women & Children Hospital in Bangalore in the Quarter. It is a boutique hospital catering to the unique healthcare needs of children and women. The hospital specializes in Obstetrics care including normal & high-risk pregnancies, comprehensive Gynecological care starting from birth, motherhood to menopause & yonder and complete Neonatal & Pediatric care including Pediatric Surgery. The hospital also provides 24 X 7 pediatric and maternal emergency services. The 49-bedded specialized hospital is strategically located in Whitefield, Bangalore and is designed to provide personalized medical care.
