

## PRESS RELEASE

### Fourth Quarter (FY 2019-20)

The Indian Hume Pipe Company Ltd (IHP) reported total revenue of **₹398.23 Crores**, for the 4<sup>th</sup> quarter of the financial year 2019-20 as against **₹523.04 Crores**, in the corresponding quarter of the previous year.

The Company has reported an EBIDTA of ₹59.51 Crores and a Net Profit of ₹25.34 Crores as against an EBIDTA of ₹63.55 Crores and a Net Profit of ₹28.92 Crores in the corresponding quarter of the previous year.

### Twelve Month Period (FY 2019-20)

The Company reported a total revenue of ₹1628.67 Crores for the 12 months period of the current financial year as against ₹1657.05 Crores in the corresponding previous year the Company has reported an EBIDTA of ₹195.39 Crores and the Net Profit of ₹73.41 Crores as against an EBIDTA of ₹197.58 Crores and a Net Profit of ₹86.31 Crores in the corresponding previous year.

### Order Book

The estimated balance value of the work as at 20<sup>th</sup> June, 2020 is ₹5007.79 Crores as against ₹4624.56 Crores as at 20<sup>th</sup> May, 2019.

The Company is L1 in one project having value of ₹134.82 Crores as at 20<sup>th</sup> June, 2020.

### Dividend

The Board of Directors at their meeting held on June 29, 2020 have recommended a dividend of ₹2.00 (100%) per equity share of face value of ₹2/- each for the financial year ended March 31, 2020, subject to approval of the shareholders in the ensuing Annual General Meeting of the Company as against a dividend of ₹3.60 (180%) per equity share of face value of ₹2/- each for the previous financial year. The curtailment of dividend is done with the view of conserving funds in uncertain times.
