Highlights and Development – For Q1 FY 26'

COMMENCED PRODUCTION OF TMT BARS

- This will not only enable the company to sweat out the existing assets, but also lead to incremental revenue and margins.
- It will lead to rebuilt the *Brand Equity* in the B to B and B to C space.
- It provides a massive opportunity to the Company to enter into fast emerging space of FE 500 / 550 D Grade of TMT bars which is seeing a major demand drive from almost all top-builders in the NCR region.

Management Comment

Commenting on the performance, **Mr. Udit Rathi, Promoter, Rathi Steel and Power Ltd. said**: "We have started the financial year on a strong note, with robust performance in the first quarter, despite challenging market conditions in particular for stainless steel long products. Our strategy to rebuild our brand legacy in the TMT bars Space seems to be delivering positive outcomes, in terms of utilization of idle assets and more importantly giving us an opportunity to capture evolving market demand of premium quality rebars (FE 500/550 D grades) from reputed builders. This move also aligns with our vision to increase our brand visibility, which will open up new business opportunities for us.

Our cost optimization project of direct rolling, commissioned last year has also started to deliver promising results, with the (net) power and fuel costs going down.

Our capacity utilization of the rolling mill division has improved substantially from approx. 25% to 39% (on a YOY basis) mainly on account of recommencement of TMT bar mill, while the capacity utilization of Steel Melting division dropped Marginally to about 55% from 64% (on a YOY basis) on account of planned maintenance shut down in April '25.

The company achieved total revenues of 155.40 Crs, an increase of approx 22% compared to corresponding quarter of last year, while the EBIDTA stood more or less constant at about Rs 6.23 Crores

Going forward, we foresee a robust opportunity to increase volumes and revenue streams, as there is enough headroom available to increase capacity utilizations.

Our focus remains on delivering sustainable value to all stakeholders. I would like to thank all our stakeholders and employees, for their continued support."

Incorporated in 1971, Rathi Steel and Power Limited manufactures and supplies steel and steel related products. The Company specializes in stainless steel products like Wire Rods, Flats, TMT Bars etc., which are primarily used in Infrastructure, Engineering, household applications. Rathi operates a plant in Ghaziabad, UP, with an installed capacity of 2,00,000 tons per annum. The Company also operates a steel melting shop with installed capacity of over 90,000 tons per annum to manufacture steel billets.
