Mumbai, 14th August, 2025: The company is happy to announce its financial results for Q1 FY 25-26.

Standalone Financial Highlights - Q1 FY25-26 v/s Q1 FY24-25

Revenue decreased by 24% from Rs. 5,236 lacs to Rs. 3,961 lacs EBIDTA decreased by 53% from Rs. 537 lacs to Rs. 252 lacs PBT decreased by 81% from Rs. 476 lacs to Rs. 90 lacs PAT decreased by 84% from Rs. 357 lacs to Rs. 60 lacs

Consolidated Financial Highlights - 01 FY25-26 v/s 01 FY24-25

Revenue decreased by 1% from Rs. 5,644 lacs to Rs. 5,561 lacs EBIDTA decreased by 38% from Rs. 612 lacs to Rs. 382 lacs PBT decreased by 88% from Rs. 483 lacs to Rs. 56 lacs PAT decreased by 91% from Rs. 364 lacs to Rs. 33 lacs

The decrease in revenue is due to postponement of sales to next quarter, because of European export license delay and site readiness delay, and hence EBIDTA and PAT were also lower.

Technical Services & Spares sales

The Company is committed to provide solutions and support on its products to customers by way of Erection, Installation, Commissioning, Testing, Training, Calibration, Annual Maintenance Contract, supply of spares parts and other services.

The company presently have 10 branch offices across India. Further the company have NABL Accredited laboratories at Mumbai and Kolkata and one technical support center at Bangalore with dedicated team.

The company's service revenues have increased from Rs. 637 Lakhs to Rs 865 Lakhs with an increase of 36% on Y-o-Y basis.
