Arshiya International's Q2FY13 Revenue Increases by 50% Net Profit Rises by 11 %,

Mumbai – November 12, 2012: Arshiya, a Unified Supply Chain & Infrastructure Group, announced consolidated total revenue of ₹ 372.57 crore for the quarter-ended September 30, 2012 as against ₹ 247.96 crore in the corresponding period last year, registering an increase of 50%.

Consolidated EBIDTA for Q2FY13 was \gtrless 108.18 crore as against \gtrless 64.72 crore in the corresponding quarter last year, registering a 67% increase. Consolidated Net Profit for the quarter also increased to \gtrless 35.43 crore up from \gtrless 31.85 crore, registering an increase of 11%.
